Mayor R. Bonnette announced that the Town of Halton Hills has received first place honours from the Lifesaving Society and has been awarded the Burlington Cup for the sixth time. The cup is awarded annually to the Ontario municipality with the largest lifesaving program in communities with a population between 50,000 and 100,000 and is based on the number of certifications issued by the municipality.

5. EMERGENCY BUSINESS MATTERS

5.1 Parking Enforcement - Relaxation

WHEREAS on April 8, 2021, the Province of Ontario declared a state of emergency and issued a Stay-at-Home order for all residents of Ontario to help stop the spread of COVID-19;

AND WHEREAS many establishments were legally required to close causing many Ontarians to be faced with financial hardships through job loss, reduction of hours and/or the cancellation of their academic school year;

AND WHEREAS due to the Stay-at-Home order residents of Halton Hills may find more family members staying in Halton Hills causing a larger

number of vehicles per household where some vehicles may have to park on the road;

AND WHEREAS the current parking regulations don't allow for parking longer than 6 hours on the road;

THEREFORE BE IT RESOLVED that Council for the Town of Halton Hills direct staff to relax parking enforcement and not ticket vehicles for parking longer than 6 hours, overnight or in 12 hour zones;

AND FURTHER THAT this remain in effect until the Provincial Stay-at-home order has ended and for any other Stay-at-Home orders the Province may issue during the COVID-19 pandemic;

AND FURTHER THAT enforcement for all other parking related matters, especially those related to safety concerns, will continue.

WHEREAS Phase 2 of Halton's Regional Official Plan Review is underway and involves research, technical analysis and community engagement around key themes including Climate Change, Natural Heritage System, and Agriculture;

AND WHEREAS a Climate Emergency was declared in 2019 by all local municipalities in Halton (Burlington, Halton Hills, Milton, and Oakville) and the Region of Halton;

AND WHEREAS Halton Regional Council has expressed strong concern about loss of prime agriculture land and negative impacts that growth beyond the existing settlement area boundary will have on future food security;

AND WHEREAS the COVID-19 pandemic has increased awareness of the loss of security our society suffers when we allow ourselves to become dependent on other countries for essentials;

AND WHEREAS accommodating growth through 2051 within the existing settlement area boundary is the most impactful strategy to address future greenhouse gas emissions generated in Halton;

AND WHEREAS the Growth Concepts Discussion Paper profiles four Growth Concepts based on 'Local Plans and Priorities' as well as an evaluation of the four Growth Concepts and their supporting technical analysis work;

AND WHEREAS the technical analysis associated with Concept 3 of the Growth Concepts Discussion Paper has demonstrated that all population growth and a considerable proportion of employment growth to 2051 could be accommodated within the existing settlement area boundary;

AND WHEREAS a greater proportion of employment growth can be accommodated in the existing settlement area boundary if Mixed Use is used to model land use for employment.

THEREFORE BE IT RESOLVED THAT Halton Region be requested to develop and add to the public consultation work an analysis that builds on Concept 3 and proposes to accommodate growth to 2051 based on no expansion of the existing Halton urban area boundaries;

AND FURTHER THAT Halton Region be requested to provide an assessment of the relative impact on greenhouse gas emissions that would reasonably be expected to be associated with each of the Growth Concepts;

AND FURTHER THAT the Province of Ontario undertake a comprehensive study of the Ontario Agricultural System to determine which farmlands are important to the on-going health and prosperity of agricultural system and should not be converted to urban uses during the current planning horizon of 2051.

AND FURTHER THAT Halton Hills communicate this Resolution to the public, and other Halton municipalities, Halton MPP's and MP's, Ontario Federation of Agriculture and Halton Federation of Agriculture.

Minutes of the Public Meeting held on Monday, April 12, 2021, 6:09 p.m., in the Council Chambers, Town of Halton Hills and Via Zoom.

Mayor R. Bonnette chaired the meeting.

Mayor R. Bonnette advised the following:

The purpose of this Public Meeting is to inform and provide the public with the opportunity to ask questions or to express views with respect to the development proposal. The Councillors are here to observe and listen to your comments; however, they will not make any decisions this evening.

As the Chair, I am informing you that when Council makes a decision, should you disagree with that decision, the Planning Act provides you with an opportunity to appeal the decision to the Local Planning Appeal Tribunal for a hearing, subject to Tribunal validation of your appeal. Please note that if a person or public body does not make oral submissions at a public meeting or written submissions to the Town of Halton Hills before the decision is made, the person or public body is not entitled to appeal the decision of the Town of Halton Hills to the Local Planning Appeal Tribunal. In addition, if a person or public body does not make oral submission at a public meeting, or make written comments to the Town of Halton Hills before the decision is made the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal, unless, in the opinion of the Tribunal, there are reasonable grounds to do so. You may wish to talk to Planning staff regarding further information on the appeal process.

The Planning Act requires that at least one Public Meeting be held for each development proposal and that every person in attendance shall be given an opportunity to make representations in respect of the proposal.

The format of this Public Meeting is as follows:

- The Town will generally explain the purpose and details of an application;
- Next, the applicant will present any further relevant information, following which the public can obtain clarification, ask questions and express their views on the proposal.

The applicant and staff will attempt to answer questions or respond to concerns this evening. If this is not possible, the applicant and/or staff will follow up and obtain this information. Responses will be provided when this matter is brought forward and evaluated by Council at a later date.

SPECIFIC PROPOSAL

This Public Meeting involves an application by 2490918 Ontario Inc. to amend the Town of Halton Hills Zoning By-law 2010-0050, as amended to permit a proposed gas station.

TOWN'S OPPORTUNITY

The Chair called upon the Town's representative, Tharushe Jayaveer, Planner - Policy/Development Review to come forward to explain the proposal.

T. Jayaveer provided an overview of the site location and context, the development proposal, planning policy context, comments and future steps as set out in the Council Report.

Agency comments included concerns regarding the current location of the on-site well and its water quality/supply. The need to update submission with regards to the number of projected vehicular trips and Right-in/Right-out movements to the site (T. Jayaveer noted that this issue has already been resolved) and the road widenings required. There were no public comments received to date.

Future steps include awaiting public comments, awaiting second submission that addresses Town and external agency comments, work through identified issue regarding water quality/supply and a final report to Council on the disposition of this matter.
