1. CALL TO ORDER

Councillor A. Lawlor, Chair called the meeting to order at 2:04 p.m.

1.a Introduction and Updates

Councillor A. Lawlor led the committee in an introduction and update session so that all of the committee members could re-introduce themselves and provide some updates on what is going on in their areas of expertise with respect to projects and the effects felt by COVID.

The committee discussed some of the challenges with re-opening in terms of safety, the need for clear communication from all levels of government, and the bleak outlook for tourism domestically.

1. What is needed in Halton Hills to attract tourism?
2. What kinds of improvements to privately-owned buildings and properties including heritage buildings are needed to attract tourism in Halton Hills?
3. How can public realm properties, amenities and infrastructure be improved to attract more tourism?

4. What additional tourism opportunities can be cultivated in the Downtowns of Georgetown and Acton?
5. What additional tourism opportunities can be cultivated in rural and/or agricultural areas?

The consultants will compile the responses, comments and suggestions from the committee to help formulate the CIP update.
