**SUBJECT:** Uniform Traffic Control By-law 1984-01 Schedule Updates

### **RECOMMENDATION:**

THAT Report No. TPW-2021-0035, dated October 12, 2021, regarding the Uniform Traffic Control By-law 1984-01 Schedule Updates be received;

AND FURTHER THAT the amendments to the listed Schedules of the Uniform Traffic Control By-law No. 1984-01 be adopted by Council.

### **KEY POINTS:**

The following are key points for consideration with respect to this report:

- An update to the Uniform Traffic Control By-law (UTCB) 1984-01 schedules is based on the results of various traffic studies and safety reviews.
- Various changes are proposed relating to No Parking Prohibitions.
- Housekeeping changes to the (UTCB) 1984-01 are required related to permissive boulevard parking.
- The identified UTCB 1984-01 schedule amendments require Council approval.
- The cost to implement the regulatory traffic sign installations is accommodated within the existing approved budget.

#### **BACKGROUND AND DISCUSSION:**

The purpose of this report is to update the Uniform Traffic Control By-law (UTCB) No. 1984-01 schedules based on the results of various traffic operational and safety reviews which require regulatory amendments to the UTCB No.1984-01.

The following changes are required:

## **Parking**

- 1. Gooderham Drive, addition of No Parking zone on the west side from a point 150m north of Argyll Road to a point 240m northwest of Argyll Road.
- 2. Gooderham Drive, addition of No Parking zone on the east side from a point 190m north of Argyll Road to a point 246m northwest of Argyll Road.

# **Parking for Restricted Times**

- 1. Mountainview Road South, deletion of No Parking zone on both sides from Eden Place/Summit Lane to 45m south of Comset Gate/Pennington Crescent, 7 a.m. to 9 a.m. and 4 p.m. to 6 p.m., Monday to Friday.
- 2. Mountainview Road South, addition of No Parking zone on both sides from Eden Place/Summit Lane to 45m south of Comset Gate/Pennington Crescent, 6 a.m. to 10 a.m. and 3 p.m. to 7 p.m., Monday to Friday.

## **Boulevard Parking**

Through Report No. TPW 2020-0027, boulevard parking has been permitted 24 hours a day, all year round. The existing 15-hour Permissive Boulevard Parking zone located on Mountainview Road South is redundant and will be removed as part of housekeeping amendments.

- 1. Mountainview Road South, deletion of 15-hour permissive parking zone on the east side from 30 m north of Eden Place to 20 m south of Pennington Crescent.
- 2. Mountainview Road South, deletion of 15-hour permissive parking zone on the west side from 30 m north of Eden Place to 225 m south of Sargent Road.

### STRATEGIC PLAN ALIGNMENT:

This report is administrative in nature and does not have an impact on the Town's Strategic Plan.

This report also identifies transportation as one of the Town's Strategic priorities.

#### **RELATIONSHIP TO CLIMATE CHANGE:**

### **PUBLIC ENGAGEMENT:**

Public Engagement has been conducted with various residents based on individual projects as required. In addition, further consultation was conducted with Ward Councillors and the Mayor where appropriate.
