SUBJECT:	Procedure By-law Amendment – Inaugural Meeting

RECOMMENDATION:

THAT Report No. ADMIN-2021-0053 dated October 18, 2021 regarding Procedure Bylaw Amendment – Inaugural Meeting be received;

AND FURTHER THAT Council approve the amendment to the current Procedure Bylaw to change the date of the Inaugural Meeting to the third Monday of November.

KEY POINTS:

The following are key points for consideration with respect to this report:

- Section 5.4 of the Procedure By-law currently states that the Inaugural Meeting is to be held on the first Monday of December
- The new term of Council begins on November 15th of a municipal election year
- Changing the Inaugural Meeting date to the third Monday of November is consistent with other municipalities in the Halton Region
- The Halton Region cannot hold their Inaugural Meeting until all four of the lowertier municipalities within the Region have held theirs

BACKGROUND AND DISCUSSION:

On May 25th, 2021 Council adopted the new Procedure By-law (By-law No. 2021-0020). Section 5.4 of the Procedure By-law currently states the Inaugural Meeting shall be held on the first Monday of December at 7:00 p.m. Section 235(1) of the *Municipal Act*, 2001 was amended in 2017, and states that a new term of Council begins on November 15th

in the year in which a municipal election is held. Therefore, holding the Inaugural Meeting on the third Monday of November allows the new term of Council to begin sooner.

At its Council meeting on September 15th, 2021 the Halton Region approved the 2022 Regional Council Calendar of Meetings where the Inaugural Meeting is scheduled for December 7th, 2022. The Halton Region cannot hold their Inaugural Meeting until all four lower-tier municipalities hold theirs. Adjusting the Inaugural Meeting date to November is consistent with the other municipalities in Halton Region and allows Halton Region to hold their Inaugural Meeting on the scheduled date of December 7th, 2022.

Section 5.4 of By-law 2021-0020 should read:

Following a Municipal Election, the Inaugural Meeting shall be held on the third Monday of November at 7:00 p.m., except when the day is a public or civic holiday in which case the meeting shall be held on the next following day that is not a public or civic holiday.
