SUBJECT: Award of Tender T-015-22 Rehabilitation of Bridge #13213 – Mountainview Road over Hungry Hollow

RECOMMENDATION:

THAT Report No. TPW-2022-0009, dated March 18, 2022, 300 - 2233 Argentia Road, Mississauga, Ontario, Canada L5N 2X7 regarding Award of Tender T-015-22 Rehabilitation of Bridge #13213 – Mountainview Road over Hungry Hollow, be received;

AND FURTHER THAT Marbridge Construction Ltd., 300 - 2233 Argentia Road, Mississauga, Ontario, Canada L5N 2X7 address, be awarded Award of Tender T-015-22 Rehabilitation of Bridge #13213 – Mountainview Road over Hungry Hollow, at a total amount of \$2,856,314.00 (plus applicable taxes);

AND FURTHER THAT the Senior Manager of Purchasing and Risk Management be authorized to issue a Purchase Order to GHD Consulting LTD, 65 Sunray Street Whitby Ontario, Canada, L1N 8Y3, in the amount of \$139,746.00 (excluding HST), for the purpose Contract Administration and Inspection Services.

AND FURTHER THAT Council authorizes the Mayor and Clerk to execute the necessary documents for this project.

KEY POINTS:

The following are key points for consideration with respect to this report:

- Staff are recommending the award of Tender to T-015-22 to complete the Rehabilitation of Bridge #13213 – Mountainview Road over Hungry Hollow to Marbridge Construction Ltd.

- Staff are recommending the issue of a Purchase Order to GHD Consulting LTD for Contract Administration and Inspection Services

BACKGROUND AND DISCUSSION:

Through a competitive Request for Proposal (RFP P-035-21) process, a contract was awarded to GHD Consulting LTD in 2021 for the Engineering Design and Contract Administration for the Rehabilitation of Bridge #13213 – Mountainview Road over Hungry Hollow.

As part of the approved 2022 Capital Budget, \$4,100,000.00 was allocated for the Construction Phase of the project.

Staff issued Tender No. T-015-22, Rehabilitation of Bridge #13213 – Mountainview Road over Hungry Hollow on February 17, 2022. Bids were posted on the Town's website and advertised on the bids and tenders website. A total of thirty-seven (37) plan takers and seven (7) bids were received. The tenders closed on March 17, 2022.

FINANCIAL IMPLICATIONS:

This report will be funded through an existing approved budget source. Funding for Mountainview Rd over Hungry Hollow Bridge Rehab (6100-26-2001) was approved as part of the 2022 capital budget for a total of \$4,100,000 and was funded from the following sources:

The total bid amount from Marbridge Construction Ltd. is \$2,856,314.00 (excluding HST) and \$2,906,585.13 (including non-refundable HST); plus the pre-approved contract for contract administration and inspection services for GHD Consulting Ltd. Of \$139,746.00 (excluding HST) and \$142,205.53 (including non-refundable HST) totaling \$3,046,790.66 (including non-refundable HST, is under the approved project budget.
