

Q1 Did you attend a virtual consultation event in the past two years?









Drawbacks: Many people have difficulty travelling to an event (away at school, travel for work or fun, age, lack of transportation), social anxieties, or hearing or mobility issues, but they still want to be involved. If you have hearing problems, it can be difficult to listen in a large group. VIRTUAL Benefits: Virtual allows more people to attend. You need moderators managing the chat bar and structure. Break out rooms are great. Drawbacks: Rural participants may not have access to enough bandwidth to participate. PERSONAL REASONS: I like to be able to attend, but sometimes I am not comfortable being in large groups for medical reasons. Inperson allows me to build relationships and to respond to body language. I remember what was said and the context more clearly. Virtual allows me to think about questions or ideas before sharing. Meetings can be recorded for reference.


