

BY-LAW NO. 2022-0028

A By-law to authorize the street name change of a section of Halton Hills Drive to Humberstone Drive

WHEREAS a municipality may pass by-laws in respect of the highways over which it has jurisdiction, in accordance with S. 27 of the Municipal Act, 2001, S.O. 2001, c. 25;

AND WHEREAS it is necessary and expedient to change the street name of the section of Halton Hills Drive shown as Parts 2 and 5, 20R-9090 (previously dedicated by By-law 91-175 registered as 777205) to Humberstone Drive;

AND WHEREAS public notice of this passing of this by-law relating to street name change of a section of Halton Hills Drive to Humberstone Drive was posted in the Town's website on April 11, 2022 in accordance with the Town's notice policies.

AND WHEREAS it is also necessary and expedient to dedicate the lands shown as Part 11 on the draft reference plan prepared by Van Harten Surveying Inc. and dated April 14, 2022 (Project 28292-20), as part of the public highway system known as Humberstone Drive such that it aligns and forms part of the section of Humberstone Drive dedicated by Plan 20M-1241;

AND WHEREAS it is also necessary and expedient to dedicate the 0.3m (1 ft) reserve shown as Part 3, 20R-9090 as part of the public highway system known as Humberstone Drive, thereby lifting the reserve and allowing public access from the section of Humberstone Drive dedicated by Plan 20M-1241;

AND WHEREAS on May 2, 2022, Council for the Town of Halton Hills approved Report No. PD-2022-0016 dated April 13, 2022, in which certain recommendations were made relating to renaming of a section of Halton Hills Drive.

NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:

- 1. THAT the section of Halton Hills Drive shown as Parts 2 and 5, 20R-9090 is hereby changed to Humberstone Drive;
- 2. THAT the lands shown as Part 11 on the draft reference plan prepared by Van Harten Surveying Inc. and dated April 14, 2022 (Project 28292-20), is hereby dedicated as part of the public highway system known as Humberstone Drive;
- **3.** THAT the 0.3m (1ft) reserve shown as Part 3, 20R-9090 is hereby dedicated as part of the public highway system known as Humberstone Drive;
- **4.** THAT Schedule "A" attached hereto shall form part of this By-law.
