



**BY-LAW NO. 2022-0029**

A By-law to dedicate certain lands as part of the Public Highway System known as Halton Hills Drive; and as Windtree Way

**WHEREAS** a municipality may pass by-laws in respect of the highways over which it has jurisdiction, in accordance with S. 27 of the Municipal Act, 2001, S.O. 2001, c. 25;

**AND WHEREAS** the Corporation of the Town of Halton Hills now deems it necessary to dedicate the lands described as Part Lot 18, Concession 8, ESQ, shown as Part 10, on a draft reference plan prepared by Van Harten Surveying Inc. dated April 14, 2022 (Project 28292-20), as part of the public highway system known as Halton Hills Drive.

**AND WHEREAS** the Corporation of the Town of Halton Hills now deems it necessary to dedicate the lands shown as Part Lot 18, Concession 8, ESQ, shown as Part 15, on a draft reference plan prepared by Van Harten Surveying Inc. dated April 14, 2022 (Project 28292-20), as part of the public highway system known as Windtree Way.

**AND WHEREAS** on May 2, 2022, Council for the Town of Halton Hills approved Report No. PD-2022-0016 dated April 13, 2022, in which certain recommendations were made relating to the dedication of certain lands as parts of the public highway system.

**NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:**

1. **THAT** the lands described as Part Lot 18, Concession 8, ESQ, shown as Part 10, on a draft reference plan prepared by Van Harten Surveying Inc. dated April 14, 2022 (Project 28292-20), are hereby dedicated as part of the public highway system and formally named Halton Hills Drive;
2. **THAT** the lands described as Part Lot 18, Concession 8, ESQ, shown as Part 15, on a draft reference plan prepared by Van Harten Surveying Inc. dated April 14, 2022 (Project 28292-20), are hereby dedicated as part of the public highway system and formally named Windtree Drive;
3. **THAT** Schedule "A" attached hereto shall form part of this By-law.
