### 1. Amendments to Town's Sign By-law

WHEREAS recent political events related to protests about pandemic precautions have resulted in some individuals flying flags on their properties which display political or hate messages;

AND WHEREAS some of these flags contain foul language and messages that encourages that harm be done to certain political figures;

AND WHEREAS some flags contain symbols that are associated with or known to support white supremacy and hate towards certain groups of people;

AND WHEREAS the Town's Sign By-law No. 2003-0065 provides that graffiti messages or markings including signs which contain offensive language are not permitted anywhere in the Town;

AND WHEREAS the definition of sign in the Town's Sign By-law No. 2003-0065 does not include flags;

AND WHEREAS residents have lodged complaints regarding the displaying of these flags in neighbourhoods where children walk by school and where others are deeply offended by the flags in their neighbourhoods;

NOW THEREFORE BE IT RESOLVED that Council for the Town of Halton Hills direct staff to bring forward a report to amend the current Sign By-law No. 2003-0065 to include flags in the definition of a sign.

**2. Motion to Reconsider the Motion from March 21, 2022 regarding "Support Subsidizing Trucks on Highway 407"**

WHEREAS The Town of Halton Hills continues to strongly oppose construction of the Hwy 413;

AND WHEREAS Halton Hills recognizes the need to address traffic congestion on Hwy 401, especially for thousands of truckers;

AND WHEREAS the proposed 413 Hwy would not provide congestion relief for many years for a problem that needs a more immediate solution;

AND WHEREAS current high tolls act as a disincentive to the transfer of traffic to the underused 407 ETR from the 401 Hwy as well as from surrounding local and regional roads;

AND WHEREAS the Provincially appointed Expert Panel that studied the proposed hwy 413 recommended cancelling the highway 413 project in favour of other more practical and more timely interventions;

AND WHEREAS one of the Expert Panel's recommendations was to incentivize the use of the 407 ETR by truckers by subsidizing the tolls for truck traffic on designated lanes of the 407 ETR;

AND WHEREAS the current provincial government demonstrated its propensity to subsidize drivers through the following measures:

- A. The elimination of license renewal stickers and fees for 7.5 million vehicles as of March 13, 2022 at a loss of \$1.1 billion a year. The government will also issue refunds from March 2020 for a loss of an additional \$1.1 billion. Future renewals will be free with no stickers to show renewals have been completed or alert police to check for unpaid traffic fines, creating more loss of revenue. This amounts to a subsidy of more than \$1 Billion annually for vehicle owners that could be restored and used to subsidize freight vehicles to encourage their use of the underutilized 407.
- B. A \$1 billion penalty to the 407 ETR operators was forgiven by the province for failure to reduce tolls during COVID, to meet 401 Hwy traffic reduction targets by attracting drivers. It is expected the same penalty will be forgiven for 2021. However, actually collecting the penalty would provide another \$1 billion to subsidize truckers using the 407;

NOW THEREFORE BE IT RESOLVED That the Town of Halton Hills continue its strong opposition to the environmentally destructive 413 Hwy;

AND FURTHER THAT the Town of Halton Hills strongly supports provincial subsidies that promote increased diversion of commercial truck traffic from the 401 Hwy to the under-utilized 407 ETR;

AND FURTHER THAT the Town of Halton Hills request the Province of Ontario work with 407 International Inc. to devise strategies to increase 407 ETR usage and enforce financial penalties established to encourage tolls that attract more drivers to use the 407 instead of the 401;

AND FURTHER THAT a copy of this resolution be forwarded to Premier Ford, The Minister of Transportation Caroline Mulroney, GTA MPPs and all GTA municipalities.

**2. Halton Region Waterpipe Smoking By-law**

Resolution No. 2022-0076

WHEREAS on October 20, 2021, Halton Region Council enacted a by-law to prohibit waterpipe smoking wherever smoking or vaping is currently

prohibited under the Smoke Free Ontario Act, 2017 and Regional By-law No. 40-20;

AND WHEREAS Report No. MO-05-21 dated October 20, 2021 from Dr. Meghani, Commissioner and Medical Officer of Health outlines the dangers and risks associated with waterpipe smoking;

AND WHEREAS Public Health Ontario's recent evidence brief on the health impacts of waterpipe smoking found that waterpipe smoke contains harmful toxins and chemicals;

AND WHEREAS exposure to waterpipe smoke is associated with multiple adverse health outcomes including respiratory diseases such as chronic obstructive pulmonary disease (COPD) and chronic bronchitis, lung cancer, heart disease, dental disease, and negative pregnancy outcomes, including infants with low birth weight;

NOW THEREFORE BE IT RESOLVED the Council for the Town of Halton Hills gives consent to Halton Region's Waterpipe Smoking By-law No. 41-21;

AND FURTHER THAT a copy of this resolution be forwarded to Halton Region.

**3. Build it Right the First Time**

WHEREAS The Town of Halton Hills made a commitment through its Climate Change Emergency Resolution adopted in May 2019 to reach net-zero GHG emissions by the year 2030, which is consistent with the current scientific data indicating that this is required by all jurisdictions if we are to avoid catastrophic climate-related events;

AND WHEREAS Residential and commercial buildings account for 33% of the GHG emissions in Halton Hills;

AND WHEREAS The Town of Halton Hills is actively implementing its Low Carbon Transition Strategy and has committed millions of dollars in the current budget to upgrade energy efficiency in its corporate building stock;

AND WHEREAS The Town of Halton Hills has adopted its third upgraded iteration of its Green Development Standards to ensure that all new

buildings are built above the current Ontario Building Code mandatory requirements;

AND WHEREAS the Ministry of Municipal Affairs and Housing is consulting on changes for the next edition of the Ontario Building Code (ERO #019-4974) that generally aligns with the draft National Model Building Code except it does not propose adopting energy performance tiers, it does not propose timelines for increasing minimum energy performance standards step-by-step to the highest energy performance tier, and according to Efficiency Canada and The Atmospheric Fund, it proposes adopting minimum energy performance standards that do not materially improve on the requirements in the current Ontario Building Code;

AND WHEREAS The greenhouse gas reduction targets set out in municipal climate Change strategies across the province will not be achievable without a commitment by the Provincial government to use this opportunity with respect to updates to Ontario Building Code to upgrade the energy efficiency of all new builds in line with other Provinces and the National Standards;

AND WHEREAS ensuring that all new buildings in the Province of Ontario are built to the highest energy efficiency means that they will not need expensive retrofits in the future and the cost of heating and cooling these buildings will be reduced from the moment they are first occupied;

AND WHEREAS the lack of strong energy efficiency standards in the current and proposed OBC have resulted in the costly development of local green development standards as individual municipalities are forced to negotiate energy upgrades as they strive to meet their GHG reduction goals (Halton Hills, Toronto, Whitby, Pickering, City of Waterloo);

THEREFORE BE IT RESOLVED THAT Council request the Province of Ontario to include energy performance tiers and timelines for increasing minimum energy performance standards step-by-step to the highest energy performance tier in the next edition of the Ontario Building Code, consistent with the intent of the draft National Model Building code and the necessity of bold and immediate provincial action on climate change;

AND FURTHER THAT if the OBC is not upgraded to the National Model Building Code that municipalities be given the authority to adopt a higher level of energy efficiency consistent with the National Building Code;

AND FURTHER THAT this resolution be provided to the Minister of Municipal Affairs and Housing, to Halton MPP's to the leaders of all Provincial political parties and to all Ontario Municipalities.
