You must send notification to the owners of neighbouring properties who may be impacted by the Noise no less than ten (10) days before the day of the hearing of the application for an exemption by way of delivery of a written notice; by personal service or prepaid first class mail;

- (a) within an Urban Class 1 Area within 60 metres of the area to which the application applies.
- (b) within a Rural Class 2 Area within 500 metres of the area to which the application applies.

Service by prepaid first class mail shall be deemed to be effective on the fifth (5) day after the order is mailed.

You must provide the Designated Official with proof of publication for two consecutive days no less than ten (10) days before the day of the hearing of the application, in a newspaper of general circulation within the Town, of a notice of intention to apply for an exemption to the Noise provisions of the Noise By-law 2010-0030, containing the information required in Part 5, Section 5.2 thereof, and stating the date upon which application to Council is intended to be made.
