

## BY-LAW NO. 2022-0057

A By-law to amend By-law No.1984-0001, being a by-law to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills.

**WHEREAS** Subsection 11(3) of the Municipal Act, S.O. 2001, Chap.25 authorizes Councils to pass by-laws for regulating traffic and parking on highways;

**AND WHEREAS** pursuant to the said authority Council for the Corporation of the Town of Halton Hills has enacted By-law No. 1984-0001, as amended, to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills;

**AND WHEREAS** Council now deems it expedient and necessary to amend the provisions of By-law No. 1984-0001;

**AND WHEREAS** on May 2, 2022 Council for the Town of Halton Hills enacted By-Law No. 2022-0027 which authorized the Commissioner of Transportation and Public Works to approve amendments on certain schedules within the Uniform Traffic Control By-law 1984-0001 and bring by-laws on the following matters to Council for approval without the submission of a staff report.

## NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:

- 1. That Schedule "1" (No Parking At Any Time Signs on Display) of By-law No. 84-1 be amended by the addition of the following:
  - 1. Mountain Street, the addition of No Parking zone on the north and south side of Mountain Street from Main Street to Tweedle Street.
- 2. That Schedule "6" (No Stopping At Any Time Signs on Display) of By-law No. 84-1 be amended by the addition of the following:
  - 1. Stewart MacLaren Road, the addition of No Stopping zone on the south side of Stewart MacLaren Road from a point 158 m east of Mountainview Road North to a point 196 m east of Mountainview Road North.
  - 2. Delrex Boulevard, the addition of No Stopping zone on the south side of Delrex Boulevard from a point 15 m west of Terry Court to Rexway Drive.
  - 3. Terry Court, the addition of No Stopping zone on the east side of Terry Court from Delrex Boulevard to a point 17 m south of Delrex Boulevard.
  - 4. Terry Court, the addition of No Stopping zone on the west side of Terry Court from Delrex Boulevard to a point 17 m south of Delrex Boulevard.
  - 5. Raylawn Crescent, the addition of No Stopping zone on the east and north side of Raylawn Crescent from a point 93 m north of Weber Drive to a point 130 m northwest of Weber Drive.

6. Raylawn Crescent, the addition of No Stopping zone on the south and west side of Raylawn Crescent from a point 240 m east of Sims Gate to a point

281 m southeast of Sims Gate.
