



**BY-LAW NO. 2023-XXXX**

A By-law to amend By-law No.1984-0001, being a by-law to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills.

**WHEREAS** Subsection 11(3) of the Municipal Act, S.O. 2001, Chap.25 authorizes Councils to pass by-laws for regulating traffic and parking on highways;

**AND WHEREAS** pursuant to the said authority Council for the Corporation of the Town of Halton Hills has enacted By-law No. 1984-0001, as amended, to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills;

**AND WHEREAS** Council now deems it expedient and necessary to amend the provisions of By-law No. 1984-0001;

**AND WHEREAS** on March 6, 2023, Council for the Town of Halton Hills approved Report No. TPW-2023-0003, dated January 20, 2023, in which certain recommendations were made relating to the Uniform Traffic Control By-law 84-01.

**NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:**

1. That Schedule "5" (Boulevard Parking – Prohibitive Signs on Display) of By-law No. 84-1 be amended by the addition of the following:
  1. Churchill Road North, the addition of No Boulevard Parking zone on the east side of Churchill Road North from a point 17 m south of Cedar Road to a point 23 m south of Cedar Road.
2. That Schedule "24" (Reduced Loads on Highways – Signs on Display) of By-law No. 84-1 be amended by the addition of the following:
  1. Main Street (Glen Williams), the addition of Reduced Loads zone from Confederation Street to 22 Side Road.
  2. Mountain Street, the addition of Reduced Loads zone from Confederation Street to Main Street (Glen Williams).
3. That Schedule "26" (Heavy Trucks Prohibited – Signs on Display) of By-law No. be amended by the deletion of the following:
  1. Main Street (Glen Williams), the deletion of No Heavy Trucks zone (7 P.M. – 7 A.M.) from Confederation Street to 22 Side Road.
  2. 22 Side Road, the deletion of No Heavy Trucks zone (7 P.M. – 7 A.M.) from Main Street (Glen Williams) to Winston Churchill Boulevard (Regional Road 19).

4. That Schedule “26” (Heavy Trucks Prohibited – Signs on Display) of By-law No. be amended by the addition of the following:
  1. Main Street (Glen Williams), the addition of No Heavy Trucks zone from Confederation Street to 22 Side Road.
  2. 22 Side Road, the addition of No Heavy Trucks zone from Main Street (Glen Williams) to Winston Churchill Boulevard (Regional Road 19).
