

That Schedule "1" of Zoning By-law 57-91, as amended by 00-138, is hereby further amended by rezoning the lands described as Part of Lot 2 Concession 8, Geographic Township of Esquesing, Town of Halton Hills, Regional Municipality of Halton, municipally known as 8250 Eighth Line N from "Agricultural (A)" in by-law 2010-0050 to "401 Corridor Prestige Industrial Zone (M7)", and "Conservation Special (O3-1)" as shown on Schedule "1" attached to and forming part of this Bylaw.
