### RECOMMENDATION:

THAT Report No. CS-2023-006 dated March 27, 2023, regarding Remuneration and Expenses paid to Members of Council and Others during the Year 2022 be received;

AND FURTHER THAT the attached Treasurer's statement on the remuneration and expenses paid to Members of Council, Local Boards and Committees in 2022 be received as information.

### KEY POINTS:

The following are key points for consideration with respect to this report:

- This report fulfills the requirements of the Municipal Act, S.O. 2001, c. 25, as amended, Section 284 (1). All payments were made in compliance with the Council Expense Policy and were funded through the 2022 approved Operating Budget.

### BACKGROUND AND DISCUSSION:

The *Municipal Act*, S.O. 2001, c. 25, as amended, Section 284 (1) requires the Treasurer to submit a statement to Council itemizing remuneration and expenses paid to each member of Council for the previous year. In addition, the Treasurer is also required to report payments made to Council appointees serving as members of any body, including Local Boards and Committees. This requirement applies to the Committee of Adjustment in 2022.

Appendix A outlines remuneration and expenses paid to each member of Council and the members of the Committee of Adjustment in 2022. All payments made were in accordance with Town policy and were provided for in the 2022 operating budget.

In 2022, the Mayor and members of Council were provided with a budgeted discretionary spending allowance of \$14,500 and \$2,700 each respectively for community outreach expenses.

Discretionary expenses could include items such as communications expenses, community or charity events, souvenirs or promotional items, and/or production costs for Ward newsletters or other mass mailings.

There were two major conferences attended by members of Council in 2022 - the Federation of Canadian Municipalities (FCM) and the Association of Municipalities of Ontario (AMO). Expenses for conferences and seminars represent all related costs including travel, meals, accommodations, and registration.

#### **STRATEGIC PLAN ALIGNMENT:**

This report aligns to the Town's Strategic plan recognizing the value to provide responsive, effective municipal government and strong leadership in the effective and efficient delivery of municipal services.

This report also identifies fiscal and corporate management as one of the Town's Strategic priorities.

This report is administrative in nature and does not directly impact or address climate change and the Town's Net Zero target.
