**SUBJECT:** Request from the property owner at 226 Main St S. (Acton) for a variance from the Fence By-law 2002-0060 as amended at 226 Main St S. (Acton) Town of Halton Hills

### RECOMMENDATION:

THAT Report No. ADMIN-2023-014 dated April 4, 2023 regarding a request from Property Owner of 226 Main St S. for a variance to the Fence By-law 2002-0060, as amended is received;

AND FURTHER THAT the fence variance contained in Report No. ADMIN-2023-014

a) be granted to Property Owner, 226 Main St S, as requested;

OR

b) be granted to Property Owner, 226 Main St S, with conditions as set out in the decision of Council;

OR

c) not be granted to Property Owner, 226 Main St S.

### KEY POINTS:

The following are key points for consideration with respect to this report:

- The Fence By-law defines a Fence to include a railing, wall, line of posts, wire, gate, boards, pickets, privacy screens or other similar substances, used to enclose or divide in whole or in part a yard or other land or to provide privacy.

- The Fence By-law defines a Privacy Screen as a visual barrier used to shield any part of a Yard from view from any adjacent Lot or Highway.
- The applicant is requesting height variance to the front yard to maintain and construct a fence of 1.8. meters (6 feet)
- There is currently an existing 6 feet wood fence located in the front yard area.
- The increase in traffic and noise due to population growth and expansion of logistic companies along Highway 25 has prompted this request.

## **BACKGROUND AND DISCUSSION:**

The municipality has enacted legislation that controls the height of fences within the municipality, under the authority of the *Municipal Act, 2001*. The property owner of 226 Main St S is seeking relief from the by-law which restricts the height of a fence in the front, side, and rear yards. The height of a fence in front or side yard cannot exceed .9 meters (3 feet) in height.

An inspection of the property was performed on April 3, 2023, which identified the lack of privacy in front yard due to noise caused by traffic.

The variance is described in the following table:

<b>By-law Requirement</b>	<b>Variance Requested</b>	<b>Reason for Variance</b>
The maximum height of a fence in the front yard is 0.9 metres (3 feet).	To permit a fence in the front yard to a maximum of 1.8 metres (6 feet) in height above effective grade.	To maximize the privacy and reduce noise for the applicants in the front yard area of the property.
