**SUBJECT:** Advisory Committees of Council – Terms of Reference

#### **RECOMMENDATION:**

THAT Report No. ADMIN-2023-020 dated May 29, 2023 regarding Advisory Committees of Council – Terms of Reference be received;

AND FURTHER THAT Council approve the Terms of Reference as set out in Appendix A, B and C;

AND FURTHER THAT these Terms of Reference be enacted for the 2022-2026 term.

### **KEY POINTS:**

- A draft Terms of Reference template was approved as an appendix to Report No. ADMIN-2023-0005
- Each of the Town's Advisory Committees of Council must establish a Terms of Reference for the 2022-2026 term using the approved template
- Section 5 of the Town's Advisory Committees of Council Administration Policy states that all Terms of Reference for ACOCs shall be approved by Council

#### **BACKGROUND AND DISCUSSION:**

Town Staff completed a review of the Advisory Committees of Council and on March 6<sup>th</sup> Council approved the ACOC Review report which included the following three appendices:

- o Administration Policy (PLCY-2023-0001)
- o Public Appointment Policy (PLCY-2023-0002)
- Terms of Reference Template

Section 5 of the Administration Policy states that all Terms of Reference for ACOCs shall be approved by Council and outlines the categories that must be included in each ACOCs Terms of Reference.

Terms of Reference are attached as appendices to this report for the following Advisory Committees of Council:

- Accessibility (Appendix A)
- Heritage (Appendix B)
- Site Alteration (Appendix C)

Terms of Reference for the following Advisory Committees of Council will be brought forward in a report at a future meeting date:

- Active Transportation
- Committee of Adjustment

Upon Council approval the Terms of Reference in Appendix A, B and C will be enacted for the current 2022-2026 term.

Each Terms of Reference submitted as Appendix A, B and C follow the Town's Terms of Reference Template to provide consistently throughout the Town's Advisory Committees of Council. The Terms of Reference will be reviewed each membership term.
