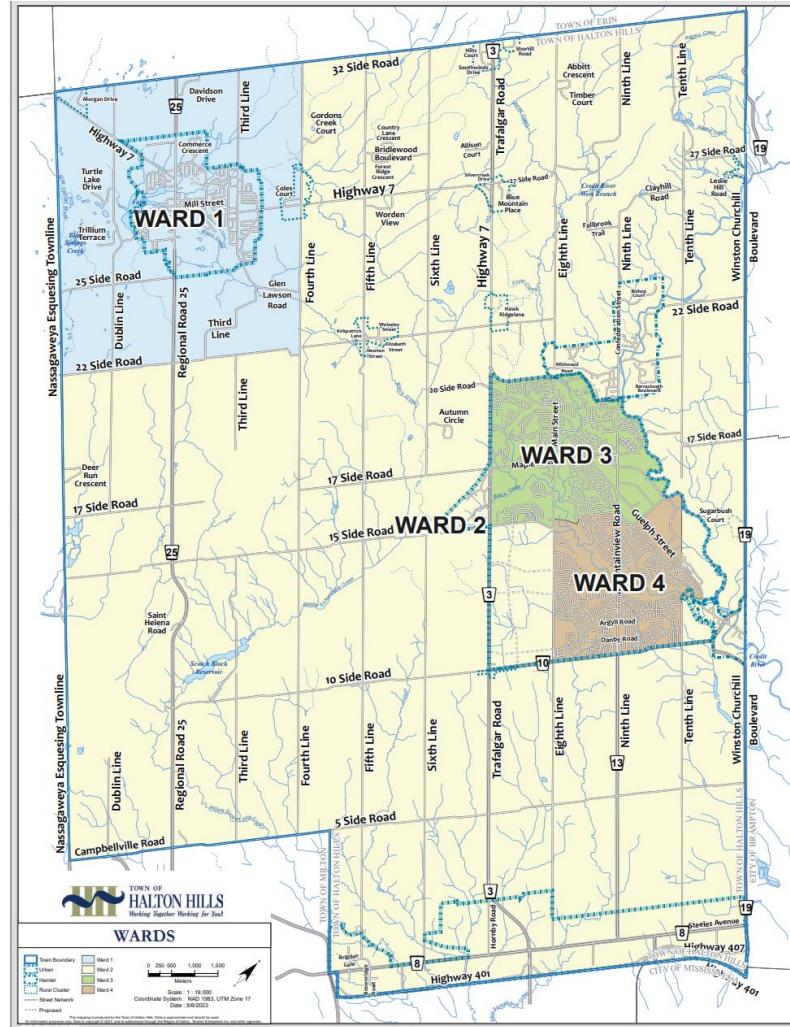

# Proposed Official Plan Amendment

- Consider policies for alternative notices for amendments to the Official Plan (in accordance with s. 17(19.3) of the *Planning Act*), and Zoning By-law Amendments (in accordance with s. 34(14.3) of the *Planning Act*).
- This would allow the Town to provide notices for public meetings via digital means rather than in a printed newspaper .
- Consider eliminating public meetings and notices for minor publicly initiated Zoning By-law Amendments like we do for Minor Official Plan Amendments
