SUBJECT: Intention to Designate under Part IV, Section 29 of the Ontario Heritage Act – 87 Main St S

RECOMMENDATION:

THAT Report No. PD-2023-008 dated January 19, 2024 and titled “Intention to Designate under Part IV, Section 29 of the Ontario Heritage Act – 87 Main St S” be received;

AND FURTHER THAT Council state its intention to designate the property at 87 Main Street South, known as Barclay’s Block, legally described as “PT LTS 4 & 5, PL 37, E OF MAIN ST OR S OF MILL ST, AS IN 845605; T/W 352338; HALTON HILLS”, under Part IV, Section 29 of the Ontario Heritage Act as recommended by Heritage Halton Hills;

AND FURTHER THAT the Town Clerk proceed with serving a Notice of Intention to Designate as mandated by Section 29(3) of the Ontario Heritage Act;

AND FURTHER THAT once the 30-day objection period has expired, and if there are no objections, a designation by-law for the property at 87 Main Street South be brought forward to Council for adoption.

KEY POINTS:

The following are key points for consideration with respect to this report:

- The property at 87 Main Street South, Georgetown meets Ontario Regulation 9/06 criteria for designation under Part IV of the *Ontario Heritage Act*; and,
- Staff are recommending that Council state its intention to designate the property.

BACKGROUND AND DISCUSSION:

The subject property is located at 87 Main Street South, Georgetown. The property is located along the east side of Main Street South within a commercial row. The existing two-storey building with rear additions has been modified at grade, as with many of the nineteenth-century commercial properties extant within Georgetown's commercial core. The property was listed on the Town's Heritage Register during Phase 1 of the Town's Heritage Register process (2010) and was identified as the last remaining section of the Barclay block, part of the downtown Georgetown streetscape and constructed in the rare Flemish bond brickwork.

The property at 87 Main Street South has been researched and evaluated by staff as part of the Town's Council-approved Heritage Register prioritization strategy to respond to *Bill 23, More Homes, Built Faster Act, 2022*¹.

On October 25, 2023, the current property owner was provided via courier a designation information package with covering letter from staff, identifying that this work was being undertaken and encouraging them to contact staff to discuss further. Staff also sent a further letter on January 3, 2024 notifying the owners that the Research and Evaluation Report for the property would be reviewed at the January 17, 2024 meeting of Heritage Halton Hills. The owner of the subject property contacted staff following publication of the report agenda and expressed support for the process.

Heritage Halton Hills reviewed the final Research & Evaluation Report for the property at its meeting of January 17, 2024, and the following motion was carried:

Recommendation No. HERITAGE-2024-006

THAT Heritage Halton Hills recommend Council issue a Notice of Intention to Designate for the property at 87 Main Street South (Georgetown) for designation under the *Ontario Heritage Act*.

The property has been identified as the last remaining portion of the mid-nineteenth century commercial building known as Barclay's Block within the community of Georgetown, associated with Francis Barclay, Bill & Co, the Cotton Brothers, and other prominent businesses, and is a contextually significant property.

As described in the Research & Evaluation Report, the identified heritage attributes of the property include:

- The setback, location, and orientation of the remaining portion of the "Barclay's Block" along Main Street South in Georgetown;
- The scale, form, and massing of the remaining portion of the mid-19th century building with modified hipped roof;

¹ Bill 23 stipulates that municipalities have a two-year window to determine whether properties on the Heritage Register warrant designation under the Ontario Heritage Act. If not so designated after two years, properties must be removed from the Heritage Register.

- The traditional storefront layout at the first storey, including the solid base panels at grade beneath large display window openings, recessed entry, and sign band below the second storey;
- Window openings at the second storey; and,
- Red brick in Flemish bond pattern, covered with stucco.

The interiors and rear elevations have not been identified as heritage attributes of the subject property at this time.

Based on the identified cultural heritage value of the property, and as the property meets criteria for designation per Ontario Regulation 9/06 criteria, staff are recommending that Council designate the property under Part IV of the *Ontario Heritage Act*.

STRATEGIC PLAN ALIGNMENT:

This report identifies natural areas and heritage as one of the Town's Strategic priorities.

RELATIONSHIP TO CLIMATE CHANGE:

This report is administrative in nature and does not directly impact or address climate change and the Town's Net Zero target.
