SUBJECT:	2024 Community Grant Program Allocations

## PURPOSE OF THE MEMORANDUM:

The purpose of this memorandum is to provide Members of Council with an overview of the 2024 Community Grant Program (CGP) allocations.

#### **BACKGROUND:**

The intent of the CGP is to assist groups (through approved grants) with their activities, events, and initiatives. Community groups and organizations must demonstrate through the CGP application process, that the objectives of their activity, event or initiative are of benefit to the community and support the strategic priorities of the Town.

Support is granted for activities, events, and initiatives that align with the key criteria, through a waiver of municipal fees (facility rental permit, road occupancy permit, loan of municipally owned equipment) or through financial support that assists with specific project expenses (such as the purchase of equipment, marketing and promotions or resources to assist with organizational effectiveness).

The CGP evaluation process ensures collaboration across all Town funding programs, to avoid duplication of Town supports, and to ensure the distribution of Town investments is coordinated and appropriate to the objectives of each funding program.

#### **COMMENTS:**

The launch of the 2024 CGP application intake began in February 2024 with a deadline to apply by March 15<sup>th</sup>, 2024. This was communicated to the public through "The Current" newsletter, communication to 140 community organizations, a dedicated Town webpage and social media posts on various platforms.

Community groups and organizations were encouraged to discuss their activity, event, or initiative with Community Development staff prior to submitting their proposal, through an individual consultation call.

A total of 16 applications were received through the 2024 CGP intake, of which 12 have been approved for grant allocation. Additionally, the pre-established 3-year agreements with organizations that host annual special events, are included within the 2024 allocations.

Funding recommendations were developed within the limits of the operational budget by the CGP selection committee and approved by the Commissioner of Recreation and Parks under delegation of authority provided through Report No. ADMIN-2022-0019.

The following table provides an overview of the 2024 allocations:

It should be noted that although most proposals were recommended for support through the 2024 CGP, there were 4 proposals submitted that were not endorsed for support, as their request:

- Did not have broad community impact; and/or
- Did not demonstrate financial need, and that potential funding was critical to their ability to carry out the activity/event/initiative; and/or
- Was a repeat application for a completed project supported through the 2023 CGP; and/or
- Failed to demonstrate collective planning, collaboration, and community engagement.

In addition, some proposals were awarded adjusted allocations from what they requested, as a portion of their request was ineligible and/or will be supported through another Town funding program.

Council approved the 2024 CGP budget for \$77,900. The funding being awarded at this time is projected to be under budget, at a total of \$72,453.67. Therefore, there is a

surplus of \$5,446.33 remaining, which staff are confident would support additional quality initiatives in our community for 2024.

Staff will keep the CGP intake open until the end of year or until the outstanding funds are allocated to additional 2024 projects, events or activities that fit within the CGP priority area. Any further applications will be reviewed and vetted by the CGP selection committee prior to approval. Staff will have further conversations with local community and neighbourhood groups to ensure their awareness of the ongoing intake for 2024.

### **CONCLUSION:**

The Town of Halton Hills is committed to supporting collaboration with all groups and organizations through a community development model and the Community Grant Program. Our community is healthier and more vibrant because of these groups and their various activities, events, and initiatives of community importance.
