**SUBJECT:** Response to Council Referred Matter - Fireworks

### **RECOMMENDATION:**

THAT Report No. FIRE-2024-003 dated April 9, 2024 regarding Response to Council Referred Matter – Fireworks, be received;

AND FURTHER THAT Council direct staff to retain a consultant to conduct a statistically valid survey to determine the community's thoughts on whether or not to implement a ban on the sale and/or discharge of fireworks (given the results of the impacts on the wildlife and environment report);

AND FURTHER THAT Council directs staff to present the results of the survey along with recommendations based on community input, associated by-law changes (if applicable) and communications to the public about the survey results and Council direction.

## **KEY POINTS:**

The following are key points for consideration with respect to this report:

- In May 2023, Council directed staff to hire a consultant (Dillon Consulting), to develop a report for the Town of Halton Hills that addressed the potential effects of fireworks on pets, wildlife, livestock and the environment. Additionally, the report would address the effects of fireworks related to post-traumatic stress disorder (PTSD).
- The consultant's findings were presented at a workshop on April 8, 2024 to educate Council on the impacts of fireworks. Council directed staff to bring forward a recommendation report, leaving the current fireworks by-law status quo until a public survey can be conducted.

#### **BACKGROUND AND DISCUSSION:**

Staff brought forward a report with proposed changes to the Fireworks By-law 2004-0122 to Council on April 17, 2023, recommending a ban on the sale of fireworks in Halton Hills, limiting the hours of discharge, and a few other housekeeping amendments. By-law 2004-0122 was repealed in its entirety and replaced with a new Fireworks By-law 2023-0032.

The new by-law had the addition of allowing fireworks on Diwali, Lunar New Year and New Year's Eve. Through discussions at the meeting Council then directed staff to consult with other municipalities on the impacts of banning the sale of fireworks, the impact fireworks have on wildlife and the potential for safe spaces for the discharge of fireworks. Council further directed staff to research the impacts fireworks have on livestock, the environment and noise with or without the ban of sale, to seek input on the dates and times fireworks may be discharged, and for staff to research an outright ban and other options or models other municipalities may be using in place of the discharge of fireworks.

Staff retained Dillon Consulting to conduct a review of the effects of fireworks to animals and the environment. The results of the consultant's literature review categorically identified negative impacts to all animals and the environment.

At a Council Workshop on April 8<sup>th</sup>, staff presented this information along with research regarding an outright ban of fireworks and options employed by other municipalities (i.e. drone light shows) in place of fireworks and provided the results of a fireworks scan of 21 surrounding municipalities.
