**6.1 Volunteer Halton Awards**

Mayor R. Bonnette announced that each year, Volunteer Halton recognizes community volunteers who have made a significant contribution to the community. I am pleased to announce that this year volunteers and staff from Halton Hills were recognized for their exceptional volunteerism at the annual Volunteer Breakfast and Award Reception held on April 16<sup>th</sup>.

The Cheers to Volunteers Award recognizes the important contributions of volunteers within an organization. Thirty-four nominations were submitted and Zachary Mattachini from our Aquatics team was the successful recipient of the award. Zachary is being recognized for demonstrating initiative, professionalism in program delivery, and going above and beyond to assist with our learn to swim program.

The Walter Mulkewich Community Development Award recognizes a group of people whose collective work has made a significant change in their community. The French Connections Program in partnership with the Hillview Active Living Centre was the successful recipient. This program is an intergenerational program where Grade 4 French immersion students from Trillium Lakeland District School Board in Huntsville, have the unique opportunity to practice French language skills by conversing with older adults whose native language is French. The program was recognized for its intergenerational approach to learning, both for language skills of the students and the media technology skills of the Hillview members as they interacted with the students through web-based conferencing.

## **6.2 Health and Safety Week**

Mayor R. Bonnette announced that May 6<sup>th</sup> to 12<sup>th</sup> is Occupational Health and Safety Week in North America.

Being very dedicated and committed to their health and safety roles, the Town of Halton Hills non-union and union joint health and safety committees are working together to bring important health and safety information to our staff.

The goal during Health and Safety Week is to focus employers, employees, partners and the public on the importance of preventing injury and illness in the workplace, at home, and in the community. The JHSC members and Human Resources work to reduce those numbers by conducting safety inspections, making staff aware of potential risks on the job, and making recommendations to Senior Management to reduce those risks.

## **6.3 Emergency Preparedness Week**

Mayor R. Bonnette announced that May 6<sup>th</sup> to 12<sup>th</sup> is Emergency Preparedness Week in Canada.

This is the 23<sup>rd</sup> year of EP Week and the theme, “Be Emergency Ready.- Stay Connected” will accompany a new initiative surrounding the Alert Ready system. This system is designed to deliver critical and potentially life-saving emergency alerts to Canadians.

In a country that borders on three oceans and spans six time zones, creating an emergency response system that works for every region is a huge challenge. That's why emergency management is a shared

responsibility. That means everyone has an important role to play, including individuals, communities, governments, the private sector, and volunteer organizations.

By taking a few simple steps, you can become better prepared to face a range of emergencies – anytime, anywhere. It is important to:

- Know the risks – Although the consequences of disasters can be similar, knowing the risks specific to our community and our region can help you better prepare.
- Make a plan – It will help you and your family know what to do
- Get an emergency kit – During an emergency, we will all need some basic supplies. We may need to get by without power or tap water. Be prepared to be self-sufficient for at least 72 hours in an emergency.

#### **6.5 Major Wind Storm May 4, 2018**

Mayor Bonnette announced that on May 4th the GTA experienced a major wind storm. Halton Hills was no different as we had experienced extremely high winds, with gusts up to 120km per hour. There were many trees damaged, traffic signals out, power outages and personal property damage. On behalf of Council I would like to thank our Public Works, Hydro and Fire Department staff for their outstanding efforts in this storm. .

The storm took the life of two arborists from Miller Tree Services. On behalf of Council we send our sincere condolences to the families and friends of these two young men. It goes to show what dangerous situations Hydro, Public Works, Police and Fire staff can face during such storm events.

## **6.6 Additional Halton Waste Services**

Councillor C. Somerville announced that as residents continue the clean up process of debris after the wind storm of Friday, May 4, 2018, Halton Region Waste Management staff have implemented the following:

- Residents may place organized oversized piles of brush at the curbside for collection;
- Extra waste disposal trucks will be brought in to help with special pick up of curbside debris; and
- Waiving the tipping fee at our Waste Management Site located at 5400 Regional Road 25 in the Town of Milton for debris and yard waste.

Halton Region staff will continue to assess the pick-up required of debris in an effort to ensure the quickest, safest and most efficient manner possible. Halton Region's website and social media will be updated to provide regular updates on the progress and measures put in place for debris collection and disposal.

AND FURTHER THAT, in keeping with the requirements of the Greenbelt Act (2005), the Province consult with the Town of Halton Hills, public and other stakeholders, on any proposed amendments to the Greenbelt Plan and its boundary, including any potential addition of the whitebelt lands into the Greenbelt, prior to any such changes being made;

**15.1 Support of Aggregate Property Appeal by the County of Wellington**

WHEREAS The Corporation of the Town of Halton Hills (the "Municipality") has been advised that The Corporation of the County of Wellington (the "County of Wellington") has appealed certain decisions of the Municipal Property Assessment Corporation ("MPAC") with respect to some properties within the geographic boundaries of the County of Wellington that are used for the purposes of aggregate resources or gravel pits (the "Aggregate Property Appeals");

AND WHEREAS previous assessment methodology valued areas that were used for aggregate resources or gravel pits ("Aggregate Resource Properties") at industrial land rates on a per acre basis of the total site and such properties were formally classified and taxed as industrial lands;

AND WHEREAS Council of the Municipality supports a fair and equitable assessment system for all Aggregate Resource Properties;

AND WHEREAS MPAC, without municipal consultation, determined with the participation of the Ontario Stone, Sand and Gravel Association (the "OSSGA"), revised criteria for assessing Aggregate Resource Properties (the "Revised Valuation Methodology");

AND WHEREAS the Municipality has concerns that the revised criteria does not fairly assess the current value of the Aggregate Resource Properties.

NOW THEREFORE BE IT RESOLVED THAT:

1. Council of The Corporation of the Town of Halton Hills hereby supports the Aggregate Property Appeals filed by The Corporation of the County of Wellington.
2. Council of The Corporation of the Town of Halton Hills does not consider the revised criteria for assessment of Aggregate Resource Properties as a fair method of valuation for these properties.
3. Council of the Corporation of the Town of Halton Hills further supports the Corporation of Country of Wellington in its efforts to achieve a fair and equitable assessment system for Aggregate Resource properties in Ontario.
