

## BY-LAW NO. 2024-0046

A By-law to amend By-law No. 2023-0094, being a by-law to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills.

**WHEREAS** pursuant to the said authority Council for the Corporation of the Town of Halton Hills has enacted By-law No. 2023-0094, as amended, to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills;

**AND WHEREAS** Council now deems it expedient and necessary to amend the provisions of By-law No. 2023-0094;

**AND WHEREAS** on June 17, 2024, Council for the Town of Halton Hills approve Report No. TPW-2024-014, dated May 8, 2024, in which certain recommendations were made relating to Uniform Traffic Control By-law 2023-0094.

## NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:

**1.** That Schedule "13" (Intersection – Stop Signs) – Non-Connecting Link – Georgetown, Section 7 (2), be amended as follows with the **addition** of:

Column 1 Intersection	Column 2 Direction of Traffic	Column 3 Highway
Morden Neilson Way and Russell Street	Northbound	Morden Neilson Way
Morden Neilson Way and Hall Road	Westbound	Morden Neilson Way

**2.** That Schedule "15" (Intersections – Yields Signs) – Non-Connecting Link – Georgetown, Section 8 (2), be amended as follows with the **deletion** of:

Column 1 Intersection	Column 2 <u>Direction of Traffic</u>	Column 3 <u>Highway</u>	
Morden Neilson Way and Russell Street	Northbound	Morden Neilson Way	
Morden Neilson Way and Hall Road	Westbound	Morden Neilson Way	

**3.** That Schedule "29" (Community Safety Zones – Signs on Display) – Non-Connecting Link – Acton, Section 4 (I) (j), be amended as follows with the **deletion** of:

Column 1 Highway(s)	Column 2 Location from	Column 3 Location to	Column 4 <u>Time Period</u>
Churchill Road North	Tanners Drive (North)	Peel Street	Any Time

**4.** That Schedule "29" (Community Safety Zones – Signs on Display) – Non-Connecting Link – Acton, Section 4 (I) (j), be amended as follows with the **addition** of:

Column 1 Highway(s)	Column 2 Location from	Column 3 Location to	Column 4 <u>Time Period</u>
Churchill Road North	Trinity Court	Peel Street	Any Time
