

BY-LAW NO. 2024-0069

A By-law to amend By-law No. 2023-0094, being a by-law to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills.

WHEREAS pursuant to the said authority Council for the Corporation of the Town of Halton Hills has enacted By-law No. 2023-0094, as amended, to regulate traffic and parking on highways under the jurisdiction of the Town of Halton Hills;

AND WHEREAS Council now deems it expedient and necessary to amend the provisions of By-law No. 2023-0094;

AND WHEREAS Council for the Town of Halton Hills enacted By-Law No. 2023-0046 which authorized the Commissioner of Transportation and Public Works to approve amendments on certain schedules within the Uniform Traffic Control By-law No. 2023-0094 and bring by-laws on the following matters to Council for approval without the submission of a staff report.

NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:

1. That "Schedule 13" (Intersections – Stop Signs) – Non-Connecting Link – Rural, be amended as follows with the **addition** of:

Column 1 Intersection	Column 2 Direction of Traffic	Column 3 Highway
Eighth Line and 22 Side Road	Northbound	Eighth Line

2. That "Schedule 23" (Rates of Speed – Signs on Display) – Non-Connecting Link – Rural, be amended as follows with the **deletion** of:

5. That "Schedule 23" (Rates of Speed – Signs on Display) – Non-Connecting Link – Rural, be amended as follows with a statutory speed limit reduction from 80 km/h to 50 km/h, with the **addition** of:

6. That "Schedule 23" (Rates of Speed – Signs on Display) – Non-Connecting Link – Rural, be amended as follows with a statutory speed limit reduction from 60 km/h to 50 km/h, with the **addition** of:

Sixth Line	950 m north of 17 Side Road	650 m south of 22 Side Road	50 km/h
