1. CALL TO ORDER

Councillor M. Albano, Chair called the meeting to order at 6:30 pm.

4. SCHEDULED ITEMS FOR DISCUSSION

4.a Inclusive Recreation

- S. Howard, Director of Recreation Services, made a presentation to the committee regarding Inclusive Recreation.
- S. Howard advised the committee that goal 2 of the Recreation and Parks Strategic Action Plan is to increase inclusion and access to recreation for populations that face constraints to participation. As part of the Town's initiatives to promote inclusion and access are levels of support, professional instructors and inclusion facilitators, recreation partners, financial assistance and access to resources.

Recreation and Parks is experiencing increased demand for one-on-one support for camps, more supports in aquatics and with an aging population more adult participants requiring additional supports for Town offered programs. To assist with this recreation staff, work with community groups and leverage services available in the community as well as increasing internal resources such as staff and programming to meet the demands.

Recreation and Parks staff will continue to respond to the demands with dedicated inclusion resources and looking at best Canadian practices in Inclusive Recreation to model Town programming.

4.b Accessible Signals Update

M. Roj, Traffic Coordinator, made a presentation to the committee regarding Accessible Signals. M. Roj noted that three projects were completed in 2024. Signals were updated at the following locations:

- Mountainview Road South & Barber Drive
- Guelph Street & Mountainview Road
- Main Street North & Moore Park Crescent

Part of updating and improving accessible signals is the installation of tactile surfaces, this became a requirement in 2016. M. Roj provided an overview of how the signals and tactile plates work and noted that the Town commenced the Accessible Pedestrian Push Button project in 2006 and with the installation of the above signals the implementation of the initial project is complete. Traffic will continue to install new sidewalk platforms with tactile plates in 2025 at the signalized intersections.

M. Roj offered to do an in-person demonstration at a future meeting.

4.c John Elliott Theatre (JET) Hearing Loop Update

This item will be moved to a future meeting.

4.d Accessibility CIP - Application

E. Kaiser, Manager of Economic Development and Innovation, made a presentation to the committee regarding an Accessibility Application through the Community Improvement Plan project for King's Cove Medical Clinic and IDA Pharmacy.

E. Kaiser advised the committee that the King Cove Medical Clinic & IDA Pharmacy are looking to add an accessible door to the main door of the clinic and to create an accessible washroom. The fund will match 50% of the project up to a maximum of \$5,000. The proposed project will cost roughly \$11,875 + HST and therefore would be eligible for the maximum amount of \$5,000.

Staff requested feedback from the committee about the application to assist staff in ensuring the application meets the accessibility requirements.

L. McKenzie noted that the application did not include grab bars or the height of the toilet. L. McKenzie advised staff that for a washroom to be truly accessible the toilet height must be a minimum of 19" and a maximum of 21" and the washroom needs to have grab bars on either side of the toilet.

E. Kaiser noted the information provided by L. McKenzie and will ensure that these are included in the specifications of the washroom project prior to providing the funds.

Dear The Honorable Doug Ford and The Honorable Michael Parsa,

I am writing on behalf of Woodstock City Council to express the urgent and pressing need for adequate and sustainable funding for the Children's Aid Society of Oxford County and other child welfare agencies throughout Ontario. These organizations play a vital role in safeguarding and enhancing the health, well-being, and safety of our children, youth, and families and deserves appropriate support and attention from our elected officials.

Our community, like many across the province, relies on the Children's Aid Society and other child welfare agencies to not only protect children and youth from abuse or neglect, but provide critical crisis intervention, early intervention, and preventative services. Their work ensures children receive necessary care at the most crucial times, close to their own homes, allowing families to remain intact and thrive together.

The lack of access to healthcare, mental health supports, poverty reduction initiatives and affordable housing is taking a toll on families and caregivers. These systemic shortfalls propel child welfare agencies into roles they were never intended to assume, filling gaps in services to ensure the well-being of children, youth, and families.

Without sufficient financial backing, these agencies are strained to a breaking point. They operate without the ability to deny families the services they desperately need. They cannot turn clients away, manage waitlists, or declare services unavailable. Yet, even with remarkable community partnerships, these agencies lack the means to expedite or ensure access to necessary treatments for those in their care.

The repercussions of this funding deficit extends well beyond individual families, affecting the community at large. Our local Children's Aid Society is supporting an ever-increasing number of youth exhibiting complex behaviors. These challenges translate into higher intervention costs, increases costs for and pressure on police and emergency service providers.

The lack of access to critical early intervention services is correlating to a distressing rise in youth homelessness. The financial sustainability and stability of the child welfare sector can no longer be deferred

for debate. It is imperative the funding formula is updated to prioritize trauma-informed, culturally relevant and proactive care.

On behalf of Woodstock City Council, I urge the province to prioritize and support the financial needs of these vital agencies. All levels of government must work together to improve upstream intervention and support to prevent the tragic outcomes we are seeing as a result of inadequate funding.

Thank you for considering this urgent matter that affects our community and its future generations.







Report

Executive Summary

- This report sets out the interim Regional property tax levy for 2025.
- The amount collected through the interim Regional property tax levy is equal to 50% of the taxes raised in 2024.
- The interim Regional property tax levy is collected by the Local Municipalities in February and April, and remitted to the Region in March and May

Background

Municipalities levy property taxes to meet their financial requirements on a calendar year basis. However, for numerous reasons, such as the timing of receipt of the final tax assessment roll, approval of municipal budgets, and receipt of the provincial education tax rates and provincial property tax policies, most municipalities finalize their annual tax rates mid-way through their operating cycle. To allow for a municipality's need to secure funds through tax collection before their tax rates are finalized, Section 316(1) of the *Municipal Act*, 2001, permits upper-tier municipalities (Halton Region) to pass an interim Regional property tax levy by-law. This legislation allows the Region to

requisition taxes from each of the lower-tier municipalities (Local Municipalities) on an interim basis up to an amount equal to 50% of the taxes collected in the previous year. Under Ontario's property tax collection system, Local Municipalities collect property taxes for regional, local and school board purposes. In Halton, the four Local Municipalities collect taxes in four installments, two interim levies (February and April) and two final levies (June and September) which are then distributed to the Region and School Boards. Through the provisions of the *Municipal Act, 2001*, amounts collected on the interim levies will raise funds up to an amount equal to 50% of the taxes raised in 2024.

Discussion

The 2024 final Regional property tax requisition as detailed in Schedule A to By-law No. 10-24 is \$525,734,316. The interim Regional property tax requisition as authorized through this report is apportioned to the Local Municipalities as follows:

The interim requisition comprises \$261,056,914.00 for general Regional and Police purposes and \$1,810,528.00 for area-specific waste management programs. As reported in FN-11-24 re: "2024 Tax Policy", for the 2024 taxation year, Regional General Services now includes basic waste, recycling and organics. The balance of Waste Management Services is the Enhanced Waste which is calculated on an area rating specific to each local municipality under Section 326 of the *Municipal Act, 2001* as service levels vary by local municipality. In Halton Region, Enhanced Waste services are provided to urban properties in the City of Burlington, the Town of Halton Hills, the Town of Milton, and the Town of Oakville. Rural properties do not receive these services.

The payment dates for the Regional requisition from the Local Municipalities are set to generally coincide with the planned collection dates for the interim tax instalments by the Local Municipalities. The due dates for the 2025 interim Regional property tax levy

will be Monday March 3, 2025 and Thursday May 1, 2025. The interim Regional property tax levy by-law will come into effect on January 1st, 2025.

The tax levy approved in the 2025 Budget and Business Plan will be incorporated into the final tax rates for 2025 and reflected on the two final bills, which will be established through the 2025 Tax Policy process and presented to Regional Council in April 2025.

Financial/Program Implications

Approval of the 2025 interim Regional property tax levy by-law ensures that the property tax revenues necessary to support Regional services, including Police, are collected and remitted on a timely basis to facilitate cash flow requirements.

WHEREAS pursuant to subsection 316 (1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended (the "Municipal Act, 2001"), the Council of The Regional Municipality of Halton ("Regional Council"), before the adoption of estimates for the year, may by by-law requisition from each of its Local Municipalities (namely, the City of Burlington, the Town of Halton Hills, the Town of Milton and the Town of Oakville) a sum not exceeding fifty per cent (50%) of the amount that, in the rating by-laws of The Regional Municipality of Halton ("Halton Region") for the previous year, was estimated to be raised in the particular Local Municipality, as adjusted by the provisions of subsections 316 (1) (b) and (c);

AND WHEREAS subsections 316 (2), (3), (4) and (5) of the Municipal Act, 2001 apply with necessary modifications to the amount requisitioned;

AND WHEREAS Regional Council is desirous of imposing such an Interim Regional Property Tax Requisition on the dates and in the amounts set out below.

NOW THEREFORE THE COUNCIL OF THE REGIONAL MUNICIPALITY OF HALTON HEREBY ENACTS AS FOLLOWS:

- 1. THAT an Interim Regional Property Tax Requisition for 2025 be imposed against each of the Local Municipalities in an amount equal to fifty per cent (50%) of the levy made by Regional Council against the said Local Municipalities for General Purposes and for Special Purposes in the year 2024.
- 2. THAT the Interim Regional Property Tax Requisition for General Purposes and for Special Purposes be apportioned among the Local Municipalities as follows:

- 4. THAT interest on amounts not paid by each Local Municipality on the due dates will be charged at a rate equal to the prime rate charged by the Regional Corporation's bankers, provided, however, that this is not to exceed the rate authorized to be charged by subsection 316(5) of the Municipal Act, 2001.
- 5. THAT the Regional Treasurer is authorized and directed to serve personally, or to mail or cause to be mailed, notices of this requisition and the amounts apportioned, to the Treasurers of the Local Municipalities.
- 6. THAT this By-law comes into force on the 1st day of January, 2025.

Too many Ontarians are being seriously injured or killed on our roads.

In 2023, there were 616 people killed and 36,090 people injured. The number of fatalities is up nearly 20% in the last ten years.

In 2021, the most recent year of complete data from MTO's Ontario Road Safety Annual Report (ORSAR), there were 561 fatalities – 426 of which occurred on municipal roads. While rural Ontario only represents 17% of the province's population, 55% of these deaths occurred on rural roads. By any measure, Ontario's rural roads are disproportionately more dangerous.

At the same time, municipal insurance premiums continue to increase. With no plausible reform being considered for joint and several liability, municipalities need to find innovative means for managing risk, particularly on their roadways,

To deal with this crisis, Good Roads has designed a multifaceted rural road safety program and have been in discussions with the Ministry of Transportation to fund it. The program would target a municipality's most dangerous roads, perform road safety audits, and install modern safety infrastructure that prevents serious injuries and save lives. This program is designed to be cost effective while also providing rural municipalities with a direct means for addressing risk associated with their roadways.

Good Roads has proposed leading a five-year \$183 million program that leverages our 131 years of municipal road expertise and our industry partnerships to quickly put in place the solutions that will address some of Ontario's most dangerous roads.

Good Roads is seeking support to address these preventable tragedies.

Whereas the Municipality of Kincardine is a proud host community of the Bruce Nuclear Generating Site where Bruce Power generates 30% of Ontario's electricity needs; and

Whereas two decades ago the Province of Ontario adopted a property tax assessment model that continues to apply to Ontario's nuclear generation facilities; and

Whereas the Province assessment model includes non-market property valuation for electricity generating properties; and

Whereas the Municipality of Kincardine undertook a study in 2024 which has shown that the Provincial assessment model is compromising fairness and shifting the tax burden away from the electricity industry properties and onto the broader property tax base within the host community; and

Whereas the study demonstrated that this is primarily attributable to the assessed value of the subject properties being held almost static over several reassessment cycles, resulting from the Provincially prescribed rules for electricity generating, transmission and distribution properties; and

Whereas the Provincial model results in a disparity between the continuously updated market values assigned to the majority of properties and the static, non-market-based formula applied to electricity industry properties means that the tax burden shifts onto non-industry taxpayers; and

Now Therefore be it Resolved That municipal staff be directed to send communication to the Premier of Ontario, Minister of Energy and Electrification, the Minister of Finance, and the local MPP, to request that the Province undertake an immediate review and update the property tax assessment model for Ontario's nuclear generation facilities and other properties within the electricity industry, and copy the Association of Municipalities of Ontario and all Ontario Municipalities.

 - b. reduce the administrative burden that the Province places on family doctors so they have more time to see their patients.
- 2. City Council forward City Council's decision to the Premier of Ontario, the Minister of Health, the Association of Municipalities of Ontario, and the municipal Clerks of Ontario's municipalities.
- 3. City Council request a direct response from the Minister of Health within 30 days.

Summary

On May 13, 2024, the City of Belleville set a good example by passing a resolution calling upon the provincial government to improve compensation and reduce administrative burden for Ontario's family physicians. Toronto should do the same.

The Province of Ontario is responsible for providing quality health care to all residents of Ontario. Family medicine is the backbone of the healthcare system and providing timely access to a primary health care provider for everyone in Ontario, is essential and should be a top Provincial Government priority. Instead, the shortage of family physicians has reached a crisis point.

Millions of Ontario residents, and hundreds of thousands of Torontonians, do not have a family doctor. Studies show that patients without a primary care provider have poorer health outcomes while costing the health care system more. Meanwhile, hospitals, emergency rooms and clinics are overloaded by residents' unmet health care needs.

The Province of Ontario could address this issue quickly and efficiently by paying fair wages to family physicians and by lessening the undue administrative burden this provincial government imposes on family doctors.

Re: The Future for Billy Bishop Airport Requires Urgent Action and a Modern Governing Agreement

Dear Minister Anand and Mayor Chow,

I am writing to you to express my support for the sustained operation and development of Billy Bishop Toronto City Airport. As the President of the Northwestern Ontario Municipal Association, I am extremely concerned to learn that the Tripartite Agreement that governs operations at the Airport expires in 2033 – less than 9 years from now.

Billy Bishop Airport provides a critical service and point of connection for the North. Many of my community members rely on Billy Bishop airport to visit family, connect through to other destinations for work, travel and tourism or to access critical medical services, the convenience and ease of Billy Bishop Airport cannot be matched. It has been reported widely that Northern Ontario communities have experience drastic reductions in air service coming out of the COVID pandemic. Reliable air connectivity available through Billy Bishop Airport is an important economic and social lifeline for my community.

We were pleased to see the Federal Government's investment in a US Customs and Border Patrol preclearance facility, which is expected to open in 2025. This is welcomed news for communities in Northwestern Ontario as it will enable more and better connections through Billy Bishop Airport and amplify the airport's already strong economic contribution. We viewed this investment in the airports long term future as recognition of the very important role the airport has come to play for the communities it connects including Northwestern Ontario - very much at odds with an agreement that expires in a matter of years.

To that end, we would implore you, as signatories to the Tripartite Agreement, to commence a process to modernize the Tripartite Agreement and secure the long-term future of Canada's 9thbusiest airport and 3rd-busiest in Ontario. My community members rely on this service, and we

want to see even more connections and expanded services to the North. As elected leaders, we have a responsibility to think past our own front doors, reflect the needs of all of our constituents and those beyond our communities who are impacted by our decisions. Certainty about the airport's long-term future should not be something we as leaders should need to think long about. The time is now for the parties of the agreement to move forward with urgency to ensure this vital piece of transportation infrastructure and the important connections it facilitates are sustained.
