**SUBJECT:** Remuneration and Expenses Paid to Members of Council and Others During the Year 2024

### RECOMMENDATION:

THAT Report No. CS-2025-009 dated March 24, 2025 regarding Remuneration and Expenses paid to Members of Council and Others during the Year 2024 be received for information.

### KEY POINTS:

The following are key points for consideration with respect to this report:

- This report fulfills the requirements of the Municipal Act, S.O. 2001, c. 25, as amended, Section 284 (1). All payments were made in compliance with the Council Expense Policy and were funded through the 2024 approved Operating Budget.

### BACKGROUND AND DISCUSSION:

The Municipal Act, S.O. 2001, c. 25, as amended, Section 284 (1) requires the Treasurer to submit a statement to Council itemizing remuneration and expenses paid to each member of Council for the previous year. In addition, the Treasurer is also required to report payments made to Council appointees serving as members of any body, including Local Boards and Committees. This requirement applies to the Committee of Adjustment in 2024.

Appendix A outlines remuneration and expenses paid to each member of Council and the members of the Committee of Adjustment in 2024. The authority for such payments is contained in By-laws 2023-0053, 2024-0019, and the 2022 Council Expense

Guidelines. All payments made were in accordance with Town policy and were provided for in the 2024 operating budget.

In 2024, the Mayor and members of Council were provided with a budgeted discretionary spending allowance of \$14,500 and \$2,700 each respectively for community outreach expenses.

Discretionary expenses could include items such as communications expenses, community or charity events, souvenirs or promotional items, and/or production costs for Ward newsletters or other mass mailings.

There were two major conferences attended by members of Council in 2024 - the Federation of Canadian Municipalities (FCM) and the Association of Municipalities of Ontario (AMO). The expenses to attend these conferences are funded from a general Council Administration Budget administered by Town staff. Conferences and seminars represent all related costs including travel, meals, accommodations and registration.

#### **RELATIONSHIP TO CLIMATE CHANGE:**
