**SUBJECT:** Amendments to various Designated By-laws listed in the AMPS

By-law 2025-0008

#### **RECOMMENDATION:**

THAT Report No. ADMIN-2025-013 dated May 13, 2025 regarding Amendments to various Designated By-laws listed in the AMPS By-law 2025-0008, be received;

AND FURTHER THAT Council approve the amendments to the various by-laws as outlined in this report;

AND FURTHER THAT Council approve and adopt the amending by-law attached as Appendix A to this report.

### **KEY POINTS:**

The following are key points for consideration with respect to this report:

- The Town is moving to Administrative Monetary Penalties for many of its regulatory by-laws that are non-parking.
- The new AMPS By-law No. 2025-0008 has 20 by-laws designated to be enforced through the AMPS program.
- Consistency is required across all of the designated by-laws to reflect no hindering or obstructing an officer during their investigation.
- Nine of the current by-laws do not have this offence listed and staff are suggesting amending the original by-laws to include this offence.

#### **BACKGROUND AND DISCUSSION:**

On February 10, 2025, Council approved and adopted By-law No. 2025-0008 being a by-law to establish a System of Administrative Monetary Penalties for regulatory by-laws, other than parking.

Twenty (20) "designated by-laws" that will be enforced through AMPS were listed and identified through the schedules of the AMPS By-law. Each schedule identifies each offence and the corresponding penalty amount for 1<sup>st</sup>, 2<sup>nd</sup> and continuous offences.

In order to maintain consistency throughout all of the designated by-laws it was realized that some of them were missing an important prohibition clause for hindering and obstructing an officer.

The following by-laws require amendments:

Once the original by-laws are amended by the above reference, the schedules in By-law 2025-0008 that pertain to each of the above noted by-laws will need to be updated to include this new offence. For each of the respective schedules the following will be added:

The addition to these by-laws will help ensure enforcement staff can have a similar approach to each by-law they are enforcing, and will provide the officers with another approach to gain compliance.
