



**BY-LAW NO. 2025-**

A By-law to amend certain Town By-laws as they relate to the designated by-laws listed in By-law No. 2025-0008, a by-law to establish a System of Administrative Monetary Penalties (Regulatory – Non-parking)

**WHEREAS** Section 391 of the Municipal Act authorizes a municipality to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of it;

**AND WHEREAS** Section 425 of the Municipal Act authorizes a municipality to pass by-laws providing that a person who contravenes a by-law of the municipality is guilty of an offence;

**AND WHEREAS** Section 426 of the Municipal Act states that no person shall hinder or obstruct, or attempt to hinder or obstruct, any person who is exercising a power or performing a duty under the Act or under a by-law passed under the Act;

**AND WHEREAS** on February 10, 2025, Council for the Town of Halton Hills adopted By-law No. 2025-0008, a By-law to establish a System of Administrative Monetary Penalties (Regulatory – Non-parking);

**AND WHEREAS** Amendments to the Designated By-laws in By-law 2025-0008 is required for consistency.

**NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:**

- 1. THAT By-law No. 2002-0060 being a By-law to regulate the erection of fences within the Town of Halton Hills be amended by:
  - a. changing the title of Section 14 to read:

**14. Enforcement and Penalties**
  - b. The addition of section 14 (3) to read:

**14.3** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.
- 2. THAT By-law No. 94-074 being a By-law to Regulate the Discharge of Firearms within the corporate limits of the Town of Halton Hills be amended by:
  - a. Adding a title to Section 6 to read:

**6. Enforcement and Penalties**
  - b. Renumbering section 6 with the original wording to now fall under **6.a**;
  - c. The addition of 6.b to read:

**6.b** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.

3. THAT By-law No. 2018-0028 being a By-law to regulate the construction, installation, widening or altering of driveways and curb cuts located on Town-owned road allowances or other property under the jurisdiction of the Town, be amended by:
  - a. The addition of section 14.3 to read:

**14.3** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.
4. THAT By-law No. 92-199 being a By-law to adopt procedures relative to construction/excavation on Public Highways in the Town of Halton Hills, be amended by:
  - a. The addition of section 20.c to read:

**20.c** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.
5. THAT By-law No. 2019-0008 being a By-law to regulate the obstruction, encumbering, injuring, or fouling of highways, and to repeal By-law No. 90-68, be amended by:
  - a. The addition of section 21.3 to read:

**21.3** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.
6. THAT By-law No. 2005-0083 being a By-law to prohibit unnecessary idling of vehicles within the Town of Halton Hills, be amended by:
  - a. The addition of section 4.7 to read:

**4.7** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.
7. THAT By-law No. 2008-0137 being a By-law to prescribe Property Standards for the maintenance and occupancy for all properties within the Town of Halton Hills, be amended by:
  - a. The addition of section 7.3 to read:

**7.3** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.
8. THAT By-law No. 94-077 being a By-law to regulate, license and control the keeping of dogs and animals other than dogs within the Town of Halton Hills, be amended by:
  - a. Changing the title of Section 12 to read:

12. Enforcement and Penalties

b. The addition of section 12.3 to read:

**12.3** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.

9. **THAT** By-law No. 2003-0065 being a By-law to regulate the size, use, location and maintenance of Signs and Advertising Devices on private and public property within the Town of Halton Hills, be amended by:

a. The addition of section 16.11 to read:

**16.11** No Person shall hinder or obstruct, or attempt to hinder or obstruct, an Officer who is exercising a power or performing a duty under this By-law.

10. **THAT** Schedules H1 & 2; E1 & 2; F1 & 2; G1 & 2; K1 & 2; L1 & 2; P1 & 2; Q1 & 2; R1 & 2; be amended by adding the following:
