Yesterday I received a copy of a resolution from the Council of the Town of Halton Hills, regarding the need for full-day, two-way GO train service between Kitchener and Toronto. Enclosed is their resolution for your ease of reference.

Town Council is expressing support for the implementation of full-day, twoway GO train service from Kitchener to Toronto by 2024 and, planning for a high speed rail line connecting London and Toronto.

I have been actively engaged on the Go train issue for some time. On July 2<sup>nd</sup>, 2014, as soon as it was possible to do so after the provincial election, I tabled a Private Members' Resolution which called upon the Government to immediately fulfill its commitment to provide full-day, two-way GO train service on the Kitchener Line between Waterloo Region and the GTA, with stops in Wellington-Halton Hills. My Resolution was one of the first ones on the Ontario Legislature's Order Paper.

Working together, we in Wellington–Halton Hills have been actively pushing for improved GO train service for our residents. The Town of Halton Hills Council and Staff have been very supportive, and we've made some significant progress. The Acton GO station was reopened in January 2013, giving our residents another access point for commuter rail service to the Greater Toronto Area. Additional new trains along the Kitchener corridor give our residents greater flexibility for their daily commute.





WHEREAS Oakville wishes to be a safe and welcoming community for all those who are residents or visitors to our town; and

WHEREAS messaging and graphic depictions felt by many to be upsetting and objectionable appear in public places, on our streets and at our doorsteps yearly; and

WHEREAS the Canadian Code of Advertising Standards includes in its provisions, outlined under Unacceptable Depictions and Portrayals - Advertisements shall not: undermine human dignity; or display obvious indifference to, or encourage, gratuitously and without merit, conduct or attitudes that offend the standards of public decency prevailing among a significant segment of the population.

THEREFORE, BE IT RESOLVED that Council direct the Director of Municipal Enforcement, in consultation with the Town Solicitor, to assess options to:

- a. regulate the display of banners/signs in public places as well as the distribution of print materials to private residences that contain extremely graphic images intended to shock, alarm, or cause dismay, including the potential for the prohibiting of the public display and distribution of such print materials for the purposes of addressing the potential of such displays to cause harm to members of the public, especially children; and
- b. report back to Council in 2019.

#### **KEY FACTS:**

The following are key points for consideration with respect to this report:

- The Region of Halton had received Quick Wins funding of \$57.6 mil from the Ministry of Transportation under the Move Ontario 2020 Quick Wins Program. At that time a BRT corridor along Dundas Road through Oakville and Burlington was identified as the project to be funded.
- The Region and the local municipalities raised concerns with the priority of the Dundas BRT and initiated the Mobility Management Strategy in order to determine Halton's longer term region-wide inter/intra transportation network
- In 2017, the Mobility Management Strategy for Halton was completed with the support of all Halton municipal staff and the CAO's. Regional Council's approval of the strategy identified the Plains/Harvester/Wyecroft/Speers corridor as a "Transit Priority Corridor"

- In 2017, in part on the basis of this longer term Mobility Management Strategy, the Town of Oakville approved an Official Plan Amendment to establish and Urban Structure which identified the Wyecroft/Speers corridor as a Transit Priority Corridor.
- In 2018, Metrolinx approved their Regional Transportation Plan which is to achieve a strong connections throughout the Region, supporting a full travel experience and promoting sustainable and healthy communities. The construction of the Wyecroft Bridge contributes to this goal by improving connections throughout Halton, supporting better access through the first and last mile and provide alternatives means of travel for both persons and goods.
- Staff support the Region in applying the Move Ontario Quick Win funding to the Wyecroft Bridge as it:
  - Allows for east/west connections for all modes of travel through Halton Region in keeping with the Metrolinx's Plans, Halton Mobility Management Strategy and the Town's Urban Structure.
  - Connections to the Bronte and Appleby GO stations are enhanced further improving the first and last mile connections supporting the Metrolinx Regional Transportation Plan and the Region's transportation planning
- No other project was identified by the Halton CAO's that would satisfy the 'Quick Win' criteria.

#### **BACKGROUND:**

In 2007, the Region applied for and obtained \$57.6 mil in Move Ontario Quick Win funding for the establishment of a BRT corridor along Dundas Street through Halton Region. More recently, the Province has indicated that the funding should be used or consideration may be given to funding other projects throughout the Metrolinx area. Halton, Burlington and Oakville staff have agreed that the funding of Dundas BRT corridor is not a current priority and as a result the Region, with the support of the local municipalities initiated the Mobility Management Strategy.

The Mobility Management Strategy identifies Plains/Harvester/Wyecroft/Speers as a Transit Priority Corridor given it provides inter regional east west connections for all modes of travel. (Appendix A).

#### **COMMENT/OPTIONS:**

The Wyecroft Road extension is an important link in the context of the region's transportation network in that it provides a needed linkage between Burlington and Oakville and helps facilitate connections to the existing Bronte GO station and Appleby GO station along the Lakeshore West line. The east-west flow in Halton

Region is constrained in this area by the Natural Heritage System as there are limited opportunities to cross the Bronte Creek.

The importance of this connection has been identified in the Regional Official Plan, Transportation Master Plan and the recently completed Mobility Management Strategy. As indicated above the corridor of Plains/Harvester/Wyecroft/Speers is identified as a 'Transit Priority Corridor' providing for east west connection linking to the key north south corridors. These corridors not only carry personal vehicles, but they provide the opportunity for bus transit, cycling and pedestrian traffic.

The Town of Oakville has relied on these key transportation linkage to develop our recently adopted urban structure. The Town's urban structure emphasizes the significance of identifying and protecting key transportation linkages and corridors, both existing and planned for all travel modes. Specifically, the urban structure clearly establishes the need for enhanced connectivity to support a more sustainable transportation system and urban structure.

In addition, Wyecroft Road is in close proximity to the Bronte GO Major Transit Station Area (MTSA) that will accommodate a significant amount of growth in the next 25 years, its development will improve access to the Bronte GO MTSA. The growth to be planned for the Bronte GO MTSA will, in part, rely on local transit connections that will benefit from enhanced access facilitated by this extension.

In context of Metrolinx's recently approved Regional Transportation Plan, this connection contributes to the goal of "Strong connections", specifically addressing the strategies of "Connect the Region" and "Optimize the system". As indicated above this connect is significantly lacking in the transportation network and will enable consideration of a higher level bus service providing improved accessibility to the Region and an alternative access to the GO stations in both Burlington and Oakville. This connection also contributes to the optimization of the transportation system by expanding the first and last mile choices in accessing major transit stations and enables local traffic to travel on the Regional arterial network, thereby optimizing highways for goods movement.

'Quick Win' funding criteria was focused on projects that would:

- Improve first mile/last mile connections to Major Transit Station Areas;
- Leverage current investment or service improvements by Metrolinx
- Address Station access or network connectivity, whether by transit or active transportation, and
- Be " design ready" wherein Provincial Environment Assessment requirements have been addressed

The Wyecroft Extension achieves each of these criteria:

- The proximity of the Bronte GO station identified as a Major Transit Station Area is enhanced with increased accessibility. Access to both work and home is increased with easier access to the Bronte GO.
- The Bronte GO station is on the Lakeshore West GO line which will be served by the RER increased service. The Wyecroft extension provides accessibility to more businesses and residents leverage access to GO services.
- Network connectivity is achieved with the Wyecroft extension as intended by the many transportation plans approved by the Region and the Town of Oakville
- The Wyecroft Extension has been approved in an EA and would fulfil the "design ready" criteria.

Staff recommend that Council support the Region in selecting the Wyecroft extension as the 'Quick Win' project and commit to build the extension in their 2019 Budget and Forecast. In addition, given the role of the connection, staff are supportive of the Region taking ownership of this section at this time and would expect to discuss the future of the balance of the corridor at the next Road Rationalization program.

### **CONSIDERATIONS:**

(A) PUBLIC

The public have been consulted throughout the EA process. No further consultation is required related to this report.

### (B) FINANCIAL

The Wyecroft Road extension between Bronte Road and Burloak Drive is included in the 2018 Development Charges Background Study at a cost of \$60 million with \$9 million identified as post period. The project is 100% growth related and is currently scheduled to begin in 2030.

Should Regional Council approve the project and include it in their 2019 Budget and Forecast there would be no change to the town's current Development Charge By-law. The Development Charges Act does not require us to update the study should there be a change to the projects identified in the Background Study. It is not unusual for projects to be delayed, construction and cost changes or unexpected grant funding. These changes would then be incorporated into the next update. In this

# **Immediate Steps to Address Gun Violence**

# **City Council Decision**

City Council on July 23, 24, 25, 26, 27 and 30, 2018, adopted the following:

1. City Council urge the Federal Government to ban the sale of handguns in the City of Toronto.

2. City Council request the Government of Canada to strengthen its proposed gun control legislation in Bill C-71, An Act to amend certain Acts and Regulations in relation to firearms, by:

a. restoring the 1977 controls on the sale of unrestricted firearms requiring firearms dealers to record the licence number, make, model and serial number of all firearms sold and subject these records to annual inspection so that police services can inspect records as needed to trace firearms used in crimes;

b. creating more stringent transport provisions for restricted firearms to limit transport outside of direct transfers between their place of storage and approved destination; and

c. prohibiting the availability, sale, possession and use of handguns, assault rifles and semi-automatic firearms in Canada, with the exception of the Canadian Armed Forces, police services or other entity that is authorized to possess firearms with legal obligations imposed by the municipal, provincial and federal governments.

3. City Council request the Federal Government to enact legislation:

a. to control guns coming into Canada along the American and Canadian border; and

b. to create gun repositories that require all long guns and hand guns to be locked up and only retrieved if and where there is a need for hunting or going to the range for target practice, such repositories to be developed in a private-public partnership.

4. City Council request the Mayor to convey to the Attorney General of Canada and Public Safety Minister City Council's request that relevant legislation, including but not limited to legislation currently before Parliament, be amended to:

a. include tougher penalties including mandatory-minimum sentences for gun traffickers;

b. direct more resources to tackle domestic firearm trafficking, specifically targeting large single purchasers of firearms; and

c. implement tougher screening for mental health and intimate partner violence issues for licensed gun owners and those seeking to acquire firearm permits.

5. City Council request the Minister of Border Security and Organized Crime Reduction and the Minister of Public Safety to advise the City of Toronto on:

a. how Ottawa can support efforts to deter or reduce the ongoing wave of gun and gangs violence in Toronto;

b. ways of stopping the free flow of illegal guns along the United States of America border into Canada; and

c. how the allocated federal funding will assist the City in eradicating the level of gun violence in Toronto.

6. City Council urge the Provincial Government to ban the sale of handgun ammunition in the City of Toronto.

7. City Council request the Government of Ontario to fulfill its campaign promise to provide an additional \$1.9 billion for mental health supports.

8. City Council request the Province of Ontario to review the Residential Tenancies Act or any other relevant legislation with a view to provide more tools to evict people for criminal behaviour specifically related to guns, gangs and drug trafficking and to provide more resources to the Landlord and Tenant Board to process evictions on a more timely basis.

9. City Council authorize the Executive Director, Social Development Finance and Administration to apply for, enter into any necessary agreements, receive, and allocate Federal Government funding for an amount of \$1.050 million in 2018 to immediately implement the Youth Violence Prevention Initiatives and expand the Community Crisis Response Program, as detailed in Revised Appendix B, #1, #3, #4 and #16 to the report (July 17, 2018) from the Interim City Manager.

10. City Council, upon receipt of Federal Government funding, authorize the Chief Financial Officer to adjust the 2018 Approved Operating Budgets for Social Development, Finance and Administration by \$0.900 million gross and \$0 net, which will support the addition of 8 temporary positions to the program complement; and Shelter, Support and Housing Administration for \$0.150 million gross and \$0 net, contingent on receipt of funding from the Federal Government.

11. City Council authorize the Executive Director, Social Development Finance and Administration to apply for up to an additional \$29.0 million in Federal Government funding

over a five year period beginning April 1, 2019, for ongoing investments in community violence intervention and prevention programming.

12. City Council authorize the City Manager to request, enter into any necessary agreements, receive, and allocate Provincial or Federal Government funding up to \$15.0 million to support enforcement initiatives, including enhanced surveillance activities and enhanced community security in local communities most impacted by gun violence as detailed in Revised Appendix B, #18, #19 and #20 to the report (July 17, 2018) from the Interim City Manager.

13. City Council authorize the City Manager to request, enter into any necessary agreements, receive, and allocate Provincial or Federal Government funding up to \$2.6 million to fund the implementation of measures in the approved Youth Equity Strategy that are deemed most effective at addressing the roots of youth violence by the General Manager, Social Development, Finance and Administration, and the Toronto Police Service.

14. City Council direct the City Manager to report through the 2019 budget process on the impact of these investments and any additional resources required to implement a proactive safe summer plan in 2019.

15. City Council request the City Manager, in collaboration with the Toronto Police Services Board, prior to awarding the contract to ShotSpotter, to consult with the office of the Ontario Information and Privacy Commissioner, and if any concerns are identified and not resolved to the satisfaction of the Ontario Information and Privacy Commissioner, that these matters be reported to the Executive Committee.

16. City Council require the City Manager to monitor the use, and potential community benefits of Shot Spotters in at-risk communities, in consultation with affected communities and the Toronto Police Services Board and to report back to City Council on the effectiveness of this technology in the first quarter of 2019.

17. City Council request the Toronto Police Services Board to immediately hire 100 new police officers, funded in 2018 through the Tax Rate Stabilization Fund, with the 2019 costs to be considered as part of the 2019 Budget Process.

18. City Council request the Toronto Police Services Board to request the Chief of Police to:

a. accelerate and increase the hiring of experienced community officers from other Services to be deployed City-wide; and

b. accelerate the implementation of a sustainable Neighbourhood Policing Model Citywide recommended through the Toronto Police Service modernization plan and to report to the Budget Committee through the 2019 budget process to address if any additional funding is required; and

c. determine how the existing Police Community Partnerships within 11, 12 and 13 Divisions could be expanded to other parts of the City where local community organizations (i.e. Ratepayer and Tenant Associations, local Business Improvement Areas, community organizations and community leaders), working in partnership with the 2018-07-23 Decisions - City Council

Toronto Police Service, can help in reducing the level of crime through crime prevention initiatives, at no cost to the Toronto Police Service.

19. City Council request the Toronto Police Service Board and the Province of Ontario to consider the recommendations in the April 2018 report, "Another Day, Another Janazah" published by the Somali Youth Research Initiative, a research project that works to analyze and better understand the scope, experience of violence and homicides among Somali-Canadian youth in Ontario, in particular, the report calls for the following recommendations:

a. the collection of disaggregated data to better address gaps in data and to do so in consultations with Somali-Canadian families and their community, regarding concerns that Somalis are dying at a greater rate than members of other community groups that are impacted by gun violence, in accordance with the Ontario Human Rights Code and the Canadian Human Rights Act;

b. the establishment of an advisory group composed of community leaders, victim families, police services, and community organizations to analyze and review current homicide investigation practices to identify existing gaps to improve clearance rates; and

c. investments in culturally-sensitive mental health resources for Somali-Canadian families by increasing the funding provisions of Enhanced Youth Outreach Workers and counsellors with a focus on mental health.

20. City Council request the Board of Directors of the Toronto Community Housing Corporation to report to the Executive Committee in the first quarter of 2019 on the concrete steps being undertaken by the Corporation to reduce the number of gun crimes in Toronto Community Housing.

21. City Council request the Chief Executive Officer, Toronto Community Housing Corporation to determine what additional resources are needed to take immediate steps to address gun and gang violence within the Toronto Community Housing Corporation complexes that are within Neighbourhood Improvement Areas, such as hiring on-site security 24 hours a day, 7 days a week, and to report back to the City Manager with any resources request for inclusion in the 2019 Operating Budget.

22. City Council direct the City Clerk to write to the Chief Coroner for Ontario, on behalf of Toronto City Council, to request an inquest be held into gun violence related deaths in Toronto to make useful recommendations directed to the avoidance of further deaths due to gun violence and to circulate this resolution to Ontario municipalities asking that they support this request for their communities.

23. City Council direct the City Manager to report back on by-law and/or policy initiatives addressing gun violence that may be taken by the City of Toronto, including potential by-laws to control the sale of handguns in Toronto.

24. City Council direct the City Manager in consultation with the Toronto Police Services Board, to establish a Gun Amnesty/Buyback program and report to City Council in the first quarter of 2019 on the status of implementation.

25. City Council request the City Manager, in consultation with the Toronto Police Services Board, to conduct a review of existing municipal initiatives in Canada that have as their aim the reduction and/or regulation in the sale, storage, and use of ammunition, and to identify possible regulatory options that may be pursued by the City of Toronto in this regard.

26. City Council request the City Manager and the Executive Director, Municipal Licensing and Standards, in consultation with the Toronto Police Services Board, to report on the findings of their review of the powers under the licensing provisions of the City of Toronto Act to regulate/and or limit the sale of ammunition, similar to the regulations implemented for fireworks.

27. City Council request the City Manager to present City Council with a comprehensive analysis of the legislative tools available to City Council to regulate the sale, storage and use of ammunition with the City's borders.

28. City Council request the Chief Planner and Executive Director, City Planning to report back in the first quarter of 2019 to the Planning and Growth Management Committee with draft options for a zoning by-law amendment that would have the effect of the City of Toronto regulating, within its borders, the sale, storage, and use of ammunition for firearms, with the exception of ammunition that is stored or used by the Canadian Armed Forces, a police force, or other entity that is authorized to store or use ammunition in connection with a legal obligation imposed by the municipal, the provincial or the federal government.

29. City Council request the Executive Director, Municipal Licensing and Standards, in cooperation with the Chief Building Official and Executive Director, Toronto Building and the Chief Planner and Executive Director, City Planning, to investigate any operating gun clubs with a shooting range in the City of Toronto to determine if they are operating legally and take appropriate action if required.

30. City Council request the Director, Real Estate Services and the General Manager, Shelter, Support and Housing and Administration to investigate and determine the feasibility of acquiring and repurposing the remaining gun clubs with shooting ranges in the City of Toronto for civic purposes.

31. City Council direct the Executive Director, Social Development Finance and Administration, in consultation with the Medical Officer of Health, to work with relevant community partners, the Toronto Community Housing Corporation and the Toronto Police Services Board, to ensure access to a range of support services and programs for victims, witnesses, and community members who experience violence.

32. City Council request the Executive Director, Social Development Finance and Administration to ensure that the Community Crisis Response Program and other trauma recovery programs include culturally appropriate methods and resources.

33. City Council request the Medical Officer of Health, the General Manager, Children Services and the Executive Director, Social Development, Finance and Administration to work together to ensure that the anti-violence strategy and initiatives include and benefit children in the middle childhood years, 9 to 14.

### Summary

At its meeting of June 26-28, 2018, Council directed the City Manager to request an emergency meeting with the Toronto Police Service, Toronto Community Housing Corporation and appropriate staff to determine what additional resources are needed to take immediate steps to address gun violence in the city, and report back to the July 23, 24 and 25, 2018 meeting of Council.

This report provides information on the emergency meeting, an overview of current initiatives to address gun violence (Appendix A), and a listing of proposed crime prevention actions for investment by the City (Appendix B) and other levels of government for Council's consideration.

This report also seeks authority for the Executive Director Social Development Finance and Administration to request funding of up to \$30.0 million from the Federal government to support Community Crime and Violence Intervention Initiatives and up to \$15.0 million from the Provincial government to support Enforcement initiatives.

The report also requests authority to increase the 2018 Approved Operating Budgets for Social Development, Finance and Administration and Shelter, Support and Housing Administration by \$1.050 million required to immediately implement responses to community violence, with expanded programming subject to confirmation of funding from Public Safety Canada.

#### **Provincial Matters**

The Ontario government has revoked <u>Regulation 144/16</u> that implements the cap-and-trade carbon tax regime. The revocation took effect July 3, 2018. The government is beginning to wind-down all programs funded out of cap-and-trade carbon tax revenues. Municipal governments have an interest, given projects they have undertaken with funding, and the potential impacts if the social housing energy refit program (Shape), is not carefully handled in light of its multi-year nature and the improvements it will bring to the quality of housing for low income people.

The *Smoke-Free Ontario Act, 2017* effective date is postponed indefinitely. The new government wants an opportunity to review the new regulations related to vaping in provincially regulated workplaces. Until the Act is proclaimed into force, the existing *Smoke-Free Ontario Act* and *Electronic Cigarettes Act, 2015* remain in force.

With legalization of recreational cannabis set for Oct.17, 2018, the <u>federal regulations to implement the</u> *Cannabis Act* are now final and include: Industrial Hemp Regulations; Qualifications for Designation as Analyst Regulations (Cannabis); Regulations Amending and Repealing Certain Regulations Made under the *Controlled Drugs and Substances Act*; and *Cannabis Act* (Police Enforcement) Regulations.
