Dear Mr. Mayor:

I am pleased to inform you that, in accordance with the commitment in Budget 2019, the Government of Canada will provide an additional \$2.2 billion to the Gas Tax Fund. This one-time top-up will provide additional support to municipalities that face infrastructure deficits to support improved productivity, economic growth, a clean environment, and help to build strong cities and communities.

This special funding will be provided to Ontario recipients under the Canada-Ontario-Association of Municipalities of Ontario-Toronto Gas Tax Fund Administrative Agreement. An amount of \$819,443,895 will be provided to Ontario as well as individual signatories, and will then be distributed to ultimate recipients in accordance with the allocation formula used for gas tax payments made in 2018, as follows:

Funds must be used in accordance with all the terms of the current Gas Tax Fund Administrative Agreement. Information on Ontario's federal Gas Tax Fund allocations per community prior to Budget 2019 can be found on Infrastructure Canada's website<sup>1</sup>.

The gas tax top-up funding is expected to be transferred following royal assent of Budget 2019.

March 14, 2019 marked one year since the Canada–Ontario Integrated Bilateral Agreement was signed.

As I know you appreciate, under the Investing in Canada Infrastructure Program, proposed projects must first be prioritized by the province before they are submitted to Infrastructure Canada for consideration.

As a reminder, through the Integrated Bilateral Agreement with Ontario, \$11.9 billion is available to the province and is broken down as follows:

- \$8.3 billion for public transit;
- \$2.8 billion for green infrastructure;
- \$407 million for community, culture, and recreation infrastructure; and
- \$250 million for infrastructure in rural and northern communities.

The one-time top-up to the Gas Tax Fund adds substantial dollars to this Agreement. More importantly, those dollars flow to you.

We believe this is an important step to take to ensure your local priorities have the resources needed so projects can get moving and, crucially, the summer construction season is not missed. We all know how important that season is to make real progress on projects, not to mention job creation locally.

In the meantime, we continue to press the Ontario government to open intakes for all four streams so as to maximize the number of projects we can build together for Ontarians in 2019 and the years ahead.

We know you have proposals ready, and last week's announcement in Budget 2019 is a clear signal that we are there to support you.

Spring is already (at last) in the air. It is time to get projects moving so we do not lose a historic opportunity to build our communities and create good-paying jobs now.

I look forward to continuing to work with you on our shared infrastructure interests.

# THE FEDERAL GAS TAX FUND IN ONTARIO

The federal Gas Tax Fund delivers over \$2 billion every year to over 3600 communities across the country. For the 2018-19 fiscal year, this represents an investment of more than \$819 million from the Government of Canada to Ontario municipalities.

The federal Gas Tax Fund (GTF) is a permanent source of annual funding to provinces and territories, who in turn flow this funding to their municipalities to support local infrastructure priorities.

**Every year, municipalities benefit** from the support and flexibility of the federal Gas Tax Fund. They can pool, bank, and borrow against this funding — providing significant financial flexibility to plan infrastructure projects over the long term. Projects are chosen locally and prioritized according to the infrastructure needs of each community.

Communities select how best to direct the funds and have the flexibility to make strategic investments across 18 different project categories.

Because many municipalities across Canada continue to face serious infrastructure deficits, **Budget 2019** proposes a **one-time transfer of \$2.2 billion** through the federal Gas Tax Fund to address short-term priorities in municipalities and First Nations communities. This will double the Government of Canada's commitment to municipalities in 2018–19, with **Ontario municipalities of all sizes sharing an additional federal investment in local infrastructure of over \$819 million, for a total of approximately \$1.64 billion**.

# **QUICK FACTS:**

- The federal Gas Tax Fund is allocated on a per capita basis for provinces, and provides a base funding amount of 0.75 percent of total annual funding for Prince Edward Island and each territory.
- On-reserve First Nations communities in provinces also receive an allocation on a per capita basis.
- The federal Gas Tax Fund has been indexed at two percent per year, meaning that it will continue to grow to provide additional support to municipalities.
- To date, more than \$23 billion has been invested in municipalities through the federal Gas Tax Fund.

# THE FEDERAL GAS TAX FUND

Eligible projects include investments in infrastructure for construction, renewal or material enhancement in each of the following categories:



- Local roads and bridges roads, bridges and active transportation infrastructure (active transportation refers to investments that support active methods of travel. This can include: cycling lanes and paths, sidewalks, hiking and walking trails).
- 2. **Highways** highway infrastructure.
- 3. **Short-sea shipping** infrastructure related to the movement of cargo and passengers around the coast and on inland waterways.
- 4. Short-line rail railway-related infrastructure for carriage of passengers or freight.
- 5. **Regional and local airports** airport-related infrastructure (excludes the National Airport System).
- 6. **Broadband connectivity** infrastructure that provides internet access to residents, businesses, and/or institutions in Canadian communities.
- 7. **Public transit** infrastructure that supports a shared passenger transport system which is available for public use.
- 8. **Drinking water** infrastructure that supports drinking water conservation, collection, treatment and distribution systems.
- Wastewater infrastructure that supports wastewater and storm water collection, treatment and management systems.
- 10. **Solid waste** infrastructure that supports solid waste management systems including the collection, diversion and disposal of recyclables, compostable materials and garbage.
- 11. **Community energy systems** infrastructure that generates or increases the efficient usage of energy, including energy retrofits of municipal buildings.
- 12. **Brownfield redevelopment** remediation or decontamination and redevelopment of a brownfield site
- 13. **Sport infrastructure** amateur sport infrastructure (excludes facilities, including arenas, which would be used as the home of professional sports teams or major junior hockey teams, e.g. Junior A).
- 14. Recreational infrastructure recreational facilities or networks.
- 15. Cultural infrastructure infrastructure that supports arts, humanities, and heritage.
- Tourism infrastructure infrastructure that attracts travelers for recreation, leisure, business or other purposes.
- 17. **Disaster mitigation** infrastructure that reduces or eliminates the long-term impacts and risks associated with natural disasters.
- 18. Capacity building investments related to strengthening the ability of municipalities to develop long-term planning practices (e.g., including local asset management planning, public transit network planning, etc.)

Note: Investments in health infrastructure (hospitals, convalescent and senior centres) are not eligible.

#### **Dear Mayor Bonnette:**

Our government for the people was elected to restore trust, transparency and accountability in Ontario's finances. As you know, the province has undertaken a line-by-line review of our own expenditures, and we have been clear that we expect our partners, including municipalities, to take steps to become more efficient as well.

Municipalities play a key role in delivering many provincial services that people across Ontario rely on. Taxpayers deserve modern, efficient service delivery that puts people at the centre and respects hard-earned dollars.

Transforming service delivery and identifying more modern, efficient ways of operating is critical and complex work. As Minister of Municipal Affairs and Housing, I recognize that many of Ontario's small and rural municipalities may have limited capacity to plan and manage transformation, depending on the resources they have available and how far they have moved on their own modernization agendas.

That is why we are providing a one-time payment in the 2018-19 fiscal year to support small and rural municipalities' efforts to become more efficient and reduce expenditure growth in the longer term.

To ensure that this investment is targeted to where it is needed most, municipal allocations are based on a formula, which takes into consideration the number of households in a municipality and whether it is urban or rural.

While this investment is unconditional, it is intended to help modernize service delivery and reduce future costs through investments in projects such as: service delivery reviews, development of shared services agreements, and capital investments. Our government believes that municipalities are best positioned to understand the unique circumstances and determine where and how this money is best spent.

I am pleased to share that Town of Halton Hills receive a one-time payment of \$156,503 which will flow in this fiscal year.

Staff from our regional Municipal Services Offices will be in touch in the coming days for your acknowledgement of this letter and to discuss any questions that you might have. I encourage you to work with ministry staff as you begin to think about the best way to proceed for your community. The Municipal Services Offices can offer advice and point to examples that may be helpful as you contemplate local solutions. In the future, we would be interested to hear about your modernization success stories.

Thank you once again for your commitment to demonstrating value for money. I look forward to continuing to work together to help the people and businesses in communities across our province thrive.

#### Dear Head of Council:

The Ontario government recognizes the importance of animal welfare. We also know that the province's animal welfare landscape is changing.

Recently, the Superior Court of Justice provided a ruling on *Bogaerts v. Attorney General of Ontario*. This ruling affects the *Ontario Society for the Prevention of Cruelty to Animals (OSPCA) Act*, which is the province's main legislation on animal welfare. While the Ontario government is appealing this decision, we intend to strengthen and improve animal welfare.

In addition, the OSPCA has advised me that it will withdraw from its current role of enforcing animal welfare legislation in the communities it serves, effective June 28, 2019.

The Ontario government is actively working to ensure appropriate measures are in place to provide animals with the protections they deserve and that Ontarians expect. To inform our next steps, my ministry will survey municipalities about the current landscape of animal welfare enforcement, including details of bylaws and existing partnerships.


Municipalities are important partners in developing an approach that ensures effective enforcement, is transparent and accountable, and ultimately improves the animal welfare system across Ontario.

At the regular meeting held on Tuesday, March 26, 2019, the Council of the Town of St. Marys received a delegation from All Aboard St. Marys, an advocacy group that is leading the fight for better Canadian rail passenger service. During the regular meeting of Council on March 26, the following resolution was passed:

**Whereas** The Corporation of the Town of St. Marys supports the National Transportation Policy, being a declaration in Section 5 of the *Canada Transportation Act*, S.C. 1996, c. 10 (as amended), which states:

It is declared that a competitive, economic and efficient national transportation system that meets the highest practicable safety and security standards and contributes to a sustainable environment and makes the best use of all modes of transportation at the lowest total cost is essential to serve the needs of its users, advance the well-being of Canadians and enable competitiveness and economic growth in both urban and rural areas throughout Canada. Those objectives are most likely to be achieved when:

- (a) competition and market forces, both within and among the various modes of transportation, are the prime agents in providing viable and effective transportation services;
- (b) regulation and strategic public intervention are used to achieve economic, safety, security, environmental or social outcomes that cannot be achieved satisfactorily by competition and market forces and do not unduly favour, or reduce the inherent advantages of, any particular mode of transportation;
- (c) rates and conditions do not constitute an undue obstacle to the movement of traffic within Canada or to the export of goods from Canada;

- (d) the transportation system is accessible without undue obstacle to the mobility of persons, including persons with disabilities; and
- (e) governments and the private sector work together for an integrated transportation system.

**Whereas** The government of Canada has subsequently stated: "we are serious about climate change" and "smart investments in transit help connection communities .... We will continue to work with communities and invest in the infrastructure they need today and into the future";

**Whereas** Abacus data has indicated that Canadians are focused on building up transit to reduce congestion and connecting communities;

**Whereas** The Canadian Transport Commission main finding at public hearings in 1977 was that there should be no further reductions to passenger rail services;

**Whereas** The frequency of VIA trains running on the North Main Line from Sarnia to London and from London through St. Marys/Stratford to Toronto has been reduced from 14 in 1977 to 4 today;

**Whereas** There is a need for balanced transportation with more people using transit and less using automobiles;

**Whereas** The changing demographic relating to house prices, housing affordability will require further expansions of transit;

**Whereas** There is a need to visit tourist sites such as the Stratford Festival, The Canadian Baseball Hall of Fame and Museum;

Whereas The annual cost of congestion to the Greater Toronto Hamilton Area economy alone is between \$7.5 and \$11 billion;

**Whereas** There are 10 million more vehicles on the road today than there were in 2000; and

**Whereas** the Town of St. Marys requests the support of this resolution from all communities served by VIA;

**Be It Resolved** That the Council of the Corporation of the Town of St. Marys recommends to the Government of Canada to adequately fund and fully support VIA Rail Canada in increasing the frequency, reliability, ticket cost and speed of VIA rail service on the North Main Line in 2019.

The Board of Directors of the Federation of Canadian Municipalities (FCM) met in Penticton, British Columbia this March 12-15—the week before a crucial federal budget, and seven months before the next federal election.

FCM is the national voice of local government, with nearly 2,000 member municipalities representing more than 90 percent of Canadians. FCM advocates for municipal priorities and delivers capacity-building tools directly to municipalities. Its priorities are driven by our elected FCM Board of Directors whose 73 members represent communities of all sizes and regions. FCM's board also oversees various committees and forums.

More than a year in the making, board members approved FCM's Strategic Plan (2019-2024) at this meeting in Penticton. It's a map to a future where municipalities have taken their place as *full partners* among orders of government—*empowered* with legislative and fiscal tools that recognize their autonomy and potential, with *enhanced capacity* to build local solutions to national priorities.

Board members also reviewed FCM's intensive efforts to shape **Federal Budget 2019**—with an eye to scaling up efforts for the coming election. Days later, we would all learn that we'd secured a major results, including a one-time doubling of Gas Tax Fund transfers and a \$1.01 billion investment in FCM's programming. Budget 2019 also launches a plan for universal broadband access—a direct response to the high-profile advocacy campaign mandated and shaped by FCM's board and its Rural Forum.

**Federal Election 2019**, just seven months off, was high on the agenda in Penticton. Board members reviewed progress on the building blocks of FCM's pre-election campaign—including government relations, platform development, communications/media, and member/stakeholder engagement. FCM's outreach to all national parties continues to intensity. Meanwhile, efforts are ramping up toward FCM's 2019 Annual Conference in Quebec City, as a major public-facing milestone for our message. As a top priority, FCM continues to develop new tools to support our most powerful resource: *FCM members and their local voices*.

Throughout the week, board members conducted pressing business through meetings of **standing committees**, **regional caucuses**, **and provincial and territorial association representatives**. Board members also adopted several **resolutions from members** calling for action on key national priorities. This included passing an amended resolution recognizing the crisis in some of Canada's energy-producing regions and calling for a strong, multi-dimensional response from the Government of Canada.




# Focus on Federal Budget 2019

As we met in Penticton, Budget 2019 was just days from being announced. For weeks, Board members had been busy reaching out to local MPs and media to support FCM's pre-budget advocacy. Together, we had been driving the message that this budget was a critical time to deliver for Canadians—by empowering the local governments closest to their daily lives.

Two working days after we left Penticton, we saw our efforts pay off in Budget 2019. This is a budget that elevates our municipal-federal partnership as the way to build better lives for Canadians across the country.

- Doubling next year's Gas Tax Transfer puts tools directly in local hands.
   Growing this proven funding for municipalities means more projects move forward—from roads and bridges to public transit.
- Prioritizing rural broadband access acts directly on local expertise.
   We led the way in making a powerful case for a plan to achieve universal high-speed Internet in Canada.
- Investing in FCM doubles down on delivering directly for Canadians.
   Delivering \$1.01 billion through FCM's Green Municipal Fund will make life more secure and affordable for milllions of Canadians.



This budget marks a turning point for FCM and local government. By elevating our partnership, it charts a path toward a fully modernized federal-municipal relationship that puts the right tools in local hands. With months to go until a pivotal federal election, that's something all national parties can agree is critical to getting more done for Canadians.

In Penticton, our Election Readiness Working Group specifially reviewed FCM's pre-budget tactics with an eye to scaling up for Election 2019. Those tactics ranged from a direct advocacy blitz to an advertising campaign on broadband that micro-targeted federal decision makers on social media and select publications.

In Penticton, board members approved FCM's next five-year strategic plan. This caps more than a year of engagement with members, staff, stakeholders and Canadian thought-leaders. Through a chain of board meetings leading to this one, directors brought deep insight to the vision and values that will guide FCM in the years ahead.

As FCM enters an exciting new phase—fresh off a turning-point budget, heading into an election—all members should feel energized by the guidance offered by this strategic plan. It's a map to a future where municipalities have taken their place as **full partners** among orders of government, **empowered** with legislative and fiscal tools that recognize their autonomy and potential, with **enhanced capacity** to build local solutions to national priorities.

## Strategic goals

Our strategic plan guides FCM to focus energy and resources to achieve six goals over the next five years.

- New intergovernmental arrangements that formally recognize the role of empowered municipalities as full partners in nation-building.
- Municipalities that have modern fiscal tools providing the resources and autonomy to address a broad range of locally-defined priorities.
- **3.** Federal policy and regulatory frameworks that enable municipalities to efficiently deliver local programs and services.
- **4.** A new generation of FCM's capacity-building initiatives that support municipal innovation, and are delivered through strategic partnerships with the federal government and relevant stakeholders.
- An FCM that utilizes innovative approaches, tools and skills in convening municipal leaders to address emerging priorities.
- 6. An FCM that is led by a modernized model of governance, is appropriately resourced, and continues to be a nimble and efficient organization achieving maximum results for the municipal sector.

# **Committees & forums**

FCM's Board of Directors oversees various committees and forums that provide crucial direction and insight on a wide range of issues and priorities. Highlights from the March 12-15 meeting include:

- Election Readiness Working Group: Discussed federal party election platforms; FCM's evolving election priorities, tools and tactics that were deployed in the run up to the Budget 2019; and those that will be needed in the run-up to the federal election (including "teasing" out priority issues, and developing new tools for outreach and engagement).
- Environmental Issues and Sustainable Development:
   Reviewed the national plastic waste strategy,
   federal policy recommendations on municipal
   waste management, infrastructure investments to
   reduce climate risks, household energy efficiency
   and the Municipalities for Climate Innovation
   Program. Also updated FCM policy on GHG
   emissions.
- Increasing Women's Participation in Municipal Government: Discussed FCM's Women in Local Government Scholarships and Awards and Toward Parity in Municipal Politics. There was also brief discussion of the recent Cabinet shuffle combining International Development and Women and Gender Equality portfolios.
- International Relations: Delved into federal plans to develop a national strategy on the Sustainable Development Goals (SDGs), efforts to align FCM programming with Canada's Feminist International Assistance Policy, FCM international projects, and engagement in global networks.
- Municipal Finance and Intergovernmental Arrangements: Discussed Election 2019 proposals for new fiscal tools, research and advocacy for a modernized federal-municipal relationship, issues related to Canada Post, and Canada's ongoing free trade negotiations. Also approved FCM's support of Halton's case on federal-municipal jurisdiction through the Legal Defense Fund.

- Municipal Infrastructure and Transportation Policy:
   Discussed funding through the Investing in Canada Plan, transit funding, impacts of autonomous vehicles, and policy updates to enable advocacy on natural infrastructure projects. Also discussed FCM submissions and legal cases related to telecommunications, FCM's Municipal Asset Management Program, and the federal government's inter-city bus strategy.
- Northern and Remote Forum: Discussed northern climate adaptation and GHG mitigation programs, the Arctic and Northern Policy Framework, the Nutrition North Canada program, the National Broadband Strategy, and the Northern and Remote Forum workshop at FCM's Annual Conference and Tradeshow.
- Rural Forum: Received a briefing on FCM's
  advocacy and research on rural economic
  development and rural issues related to federal
  policy development and programming. Also
  discussed FCM's National Broadband Strategy,
  rural-specific programming at the 2019 Annual
  Conference, and rural priorities related to FCM's
  election work on new fiscal tools.
- Social-Economic Development: Advanced housing policy and election priorities related to homelessness, supportive housing and housing affordability. Discussed FCM's reconciliation priorities for the election, particularly related to the Urban Programming for Indigenous Peoples program, and municipal-First Nation partnerships.
- Standing Committee on Community Safety and Crime Prevention: Expanded FCM's policy on substance use, addiction and emergency recovery. Recommended additional effort to address rural crime. Discussed flood insurance, floodplain mapping, the Emergency Management Strategy, DFAA eligibility criteria, federal actions on gun and gangs, and FCM advocacy on cannabis legalization.



## Resolutions

FCM members submit resolutions for the board's consideration on subjects of national municipal interest. Our resolutions process recognizes diverse voices while providing a focus for building a united municipal voice to drive concrete action. Resolutions considered in Penticton include the following:

- Federal Support for Energy Infrastructure Projects:
   Board members discussed and amended a resolution recognizing the crisis facing some of Canada's energy-producing regions. The final text calls on the federal government to support nation-building energy infrastructure projects that respect local jurisdiction, provide revenue to municipalities and meet high environmental standards. It also calls on them to provide support to energy producing regions, including by investing in projects that enable a transition to renewable energy production.
- Expand the Airports Capital Assistance Program:
   With a focus on opening up peripheral regions, the
   Board adopted a resolution to urge the federal
   government to increase funding and extend
   eligibility for the Aiports Capital Assistance
   Program to all small airports, including those
   providing commercial passenger service to fewer
   than 1,000 passengers per year.
- Gender-Based Violence: The Board approved a resolution to endorse in principle the federal government's national strategy to address genderbased violence. The resolution also calls on FCM to advocate for municipalities to be consulted on how the strategy and the funding is implemented.
- Priority Funding of Flood Prevention Capital
   Projects: The Board approved a resolution calling
   on the federal government to make infrastructure
   funding for flood prevention projects—such as the
   Disaster Mitigation and Adaptation Fund (DMAF),
   which has a \$20 million minimum threshold—more
   accessible to small communities.

- Streamlined Process for Sediment Management: Building on FCM's advocacy on the federal Fisheries Act, the Board approved a resolution calling on Fisheries and Oceans Canada to provide guidance to municipalities on how to remove debris from rivers and creeks in order to reduce flood risk in a way that limits harm to fish and fish habitat and does not require federal approval.
- Affordable Housing for Seniors: The Board approved a resolution calling on the federal government to work with community partners to develop solutions for the lack of seniors' housing and to provide the necessary long-term funding to support the construction of a full range of affordable seniors' housing choices. This resolution points to the need for funding under the National Housing Strategy to support seniors housing, especially in smaller communities, and continues FCM's longstanding affordable housing advocacy.
- Investing in Indigenous Peoples: In the spirit of reconciliation, the Board adopted a resolution calling on the federal government to undertake the investments needed to address the root causes of inequity between Indigenous and non-Indigenous Canadians. As a first step, the resolution urges collaboration with Indigenous peoples.

# **Road to Federal Election 2019**

A full year ago, FCM's Board of Directors identified the 2019 federal election as potentially transformative for municipalities, calling for the most intensive pre-election advocacy push in the history of our organization.

In Penticton—seven months from election day—board members checked on our progress and our strategy for the months ahead. This included a comprehensive update led by Policy and Public Affairs Executive Director Carole Saab. She elaborated on the core building blocks of our campaign: government relations; platform development; communications and media; member and stakeholder engagement; and the last-stretch campaign.



FCM's success in shaping Federal Budget 2019 shows that our strategy is on track. We had targeted this budget as a key milestone to advance our narrative—that empowering local leaders is the best way to build better lives for Canadians. This budget elevates our federal-municipal partnership is important ways. In doing so, it sets the tone for what's possible in Election 2019.

Our goal is to ensure that deep municipal empowerment is baked into the election platforms of all the national parties. Our efforts should foster healthy competition among parties to put forward the best commitments—the ones that best empower the governments closest to people's everyday hopes and challenges.

Ahead of Budget 2019, FCM tested communications approaches that can be scaled up toward the election. These included rich and consistent storytelling—through earned media, op-eds and government relations— emphasisizing how local leaders *build better lives*. Another example is a cost-effective advertising campaign that "micro-targeted" federal decision makers through social media and select publications.

In Penticton, board members re-enforced a core idea: *FCM members are our best campaign tool*. They provide the local voice and the local context that can make our message connect with real people. FCM is developing to support their efforts to reach out through traditional and social media, and directly with local MPs and candidates.

FCM's pre-election efforts are building toward our next big public-facing milestone: FCM's 2019 Annual Conference in Quebec City. This is a vital opportunity to connect with all parties and their leaders and to start getting them on record making early public commitments to local governments.



# **Key points**

- This budget sets the stage for more: by doubling down on working directly with municipalities to build better lives, it raises the bar for all national parties in the coming election.
- We reviewed FCM's progress toward
   <u>Federal Election 2019</u>. We continue to
   ramp up intensive efforts targeting all
   national parties—encompassing
   government relations, platform
   development, communications, and
   member/stakeholder engagement.
- This election is a historic opportunity.
   This is our time to take our place as an empowered order of govenment—to build better lives for Canadians living in communities of all sizes.





Comments on the Ministry of the Environment, Conservation & Parks' <u>discussion paper on Waste & Litter</u> are due April 20. <u>Register for AMO's webinar</u> to learn about our response.

In response to a request from AMO, the Ministry of Municipal Affairs and Housing is extending the timeline for municipal councils to compete their 10-Year Housing and Homelessness Plans until the end of the 2019 calendar year.
