Approve the Municipal Cannabis Retail Store Guidelines as set out in city manager's report CM-8-19.

Purpose:

A City that Grows

- Promoting Economic Growth

An Engaging City

- Good Governance

Background and Discussion:

AMO has suggested that municipalities consider approving a policy statement or guidelines for cannabis retail store locations identifying potential sensitive uses as defined by their community. The policy statement/guidelines assist with commenting on the location for potential stores within a municipality. Other surrounding municipalities that opted-in to recreational cannabis stores have also recently brought forward store guidelines or policy statements. This helps to clarify for the community and potential store owners where the municipality would prefer to see stores located. It also would provide clarification on when and what to expect from the municipality in providing comments to the AGCO on potential store locations.

Strategy

The province licenses all recreational cannabis retail stores through the AGCO. The City of Burlington opted-in to allow private recreational cannabis stores within the municipality on January 14, 2019 (CM-3-19). The AGCO process includes a public/agency commenting period which the City may use to provide a local perspective.

There is no obligation by the Alcohol and Gaming Commission of Ontario (AGCO) to accept or implement the City's comments to the AGCO regarding the location of a Retail Cannabis Store. However, it is important that Burlington's input continue to be provided to reflect the broader communities wishes.

Provincial regulations do not provide for any municipal enforcement or zoning mechanisms for the location of cannabis retail stores. The regulations also do not provide Municipalities the ability to differentiate this use from any other retail use. The stores are a legal entity and therefore are to be considered like any other type of retail use and must locate in areas zoned within the city for retail use (retail, commercial retail). The sole location criteria established in the provincial regulations is that a store must locate outside a 150 metre buffer of schools (as defined by the Provincial Education Act). The only provincial regulation affecting local municipalities is that stores must be in compliance with the Ontario Building Code, Fire Code and local property standards and sign by-laws.

Provincial legislation identifies that municipal and public comments to the AGCO on possible store locations can only be in reference to three areas of "Public Interest". This is defined by the Province as:

- Public health and safety
- Protecting youth
- Eliminating the illegal market

Commenting is also limited in the legislation to those that live within the municipality and the municipality itself where the application for the store has been submitted. All comments must be submitted online at iAGCO. The City of Burlington cannot submit comments on behalf of individual residents, although the City's comments will strive to represent the broader public interest. Residents are encouraged to submit their own comments to the AGCO should they wish to do so.

In speaking with staff from other opt-in municipalities (St. Catherines, Halton Hills), many were in the process of developing cannabis retail store guidelines in order to help with providing comments to the AGCO that reflect broader community interests. These municipalities had conducted similar surveys with residents to determine what their local residents considered to be other sensitive uses and where residents would prefer not to

see cannabis retail stores. Staff determined that a guideline would be a valuable tool and used the data gathered from the "Get Involved Burlington" Community survey to help inform the guidelines. Please see Appendix A for the Cannabis Retail Store Guidelines.

Staff have also determined, based on our preliminary experience with a recreational retail cannabis store, that more information for potential applicants is required. For this reason, designated staff will be providing at a minimum, a comment to all future applications under the "health and safety" area of public interest. This is to make certain that all potential applicants know that to ensure public health and safety is achieved an applicant must ensure that they do their due diligence in regard to ensuring that a cannabis retail store complies with municipal requirements. It is staff's understanding that all comments provided to the AGCO are supplied to the applicants. This will help ensure that all potential retail owners are aware of these municipal requirements.

Future:

When report CM-3-19 was approved at Council a staff direction was given to set up a Taskforce to deal with future cannabis related issues. Staff require the sunset of a current council-initiated Taskforce before this one can begin. The review and evaluation of the success of the guidelines as provided in this report will be one of the undertakings for this Taskforce.

There will also be future work in response to new legislation and regulations for additional cannabis products, including edible cannabis, cannabis extracts and cannabis topicals which will be permitted for legal sale under the Cannabis Act no later than October 17, 2019. The potential loosening of the restrictions on the number of licenses by the Province set for December 2019 and the review of any proposed regional smoke free by-laws will also be workplan items.

Staff will also formalize a Communications plan to educate potential retail cannabis store owners. This will include providing this guideline to Burlington Economic Development Corporation, Burlington Chamber of Commerce, Burlington Downtown Business Association, Aldershot Village BIA and providing the guidelines on the city's cannabis section of website. Potential retailers need to be made aware of municipal requirements and what they need to do before they commit themselves to a long-term lease.

Staff are seeking Council approval of the Cannabis Retail Store Guidelines as provided in report CM-8-19.

Appendix A

City of Burlington Cannabis Retail Store Guidelines

The Cannabis Retail Store Guidelines is to be used as the primary guidelines in providing City of Burlington comments to the Ontario Alcohol and Gaming Commission (AGCO) in response to applications for privately operated cannabis retail stores within the municipality.

The guidelines are established to address broader public interest in the evaluation of applications for a cannabis retail store authorization within the City of Burlington.

Public interest is defined in provincial regulation as:

- public health or safety
- protecting youth
- eliminating the illegal market

Provincial Requirements:

- 150 metres from schools (as defined by the Education Act), as per the provincial regulations

Municipal Requirements:

- They shall be located on properties zoned to permit retail stores (commercial, retail commercial)
- They shall be in compliance with:
 - The Ontario Building Code (permit requirements for any change of use and/or construction)
 - The Fire Code
 - City of Burlington Municipal Sign By-law
 - City of Burlington Property Standards By-law
 - And any related planning approval (i.e. Zoning Clearance Certificate, Site Plan approval)

Community Preferences:

- In addition to schools, as defined by the Education Act, a Cannabis Retail Store should strive to maintain a minimum 500 metre buffer distance from sensitive

land uses, as follows:

- municipal parks, pools and splash pads, recreation centres, libraries and arenas
- daycares
- facilities for social services, including but not limited to addiction treatment, hospitals and mental health.

- Consistent with the provincial regulations is how the 500 metre buffer distance for stand alone or shared facility will be measured. For stand alone facilities the measurement is from the property line. For shared facilities the measurement is taken from the boundary of any space occupied by the school within the building.
- Cannabis Retail Stores should strive to maintain 500 metre separation from each other to avoid clustering within permitted retail zones

Implementation:

- City Staff will review a proposed location for sensitive uses as well as identify any unknown additional circumstances that need to be considered at the time of becoming aware of a new application for a Cannabis Retail Store.
- The primary determinants in selecting sensitive uses are the potential influence that the location of a Cannabis Retail Store may have upon individuals with addiction and/or mental health challenges or where the community considered sensitive uses through the COB survey administered Dec 2018 – Jan 2019.
- Given the short 15-day timeline provided by the AGCO to comment on proposed retail cannabis stores, one staff person will be designated to be responsible to liaise with other city departments, identify any localized conditions or concerns and provide comment on behalf of the municipality to the AGCO within the 15-day commenting period.
- Every cannabis retail store application in Burlington will, at a minimum, receive the following comments from the municipality. Under Public Health or Safety:

“As part of the due diligence process an applicant shall ensure that compliance with the Municipal Zoning By-law and the Ontario Building Code for the necessary permits for any change of use and/or construction is investigated and attained.”

At its May 22, 2019 meeting, Hamilton City Council discussed the changes being proposed for public health in Ontario and their potential effects. Before I convey the recommendations that arose from that discussion, I would like to commend you and your colleagues for your announcement on June 3rd that any changes to the provincial funding of public health will not affect the current fiscal year.

Hamilton's City Council recommends that any restructuring or modernization of local Public Health take into account the following principles:

- That its unique mandate to keep people and our communities healthy, prevent disease and reduce health inequities be maintained;
- That its focus on the core functions of public health, including population health assessment and surveillance, promotion of health and wellness, disease prevention, health protection and emergency management and response be continued;
- That sufficient funding and human resources to fulfill its unique mandate are ensured.
- That the focus for public health services be maintained at the community level to best serve residents and lead strategic community partnerships with municipalities, school boards, health care organizations, community agencies and residents;
- That there be local public health senior and medical leadership to provide advice on public health issues to municipal councils and participate in strategic community partnerships. The importance of this has been highlighted by the recent cluster of HIV among those using intravenous drugs in Hamilton;



- That local public health services be responsive and tailored to the health needs and priorities of each local community, including those of vulnerable groups or those with specific needs such as the indigenous community;
- That representation of municipalities on any board of health be proportionate to both their population and to the size of the financial contribution of that municipality to the Regional Public Health Entity;
- That any transition be carried out with attention to good change management, and while ensuring ongoing service delivery.

For decades Hamilton has enjoyed and benefited from the knowledge, skills and implementation of 'preventive maintenance' that our public health staff have provided which we know has resulted in our community avoiding many costly health 'breakdowns' that would have arisen otherwise! As we move forward we also look forward to working directly with you and collaborating with our provincial colleagues through the relevant partnerships, such as the Association of Municipalities of Ontario (AMO), the Association of Local Public Health Agencies (aLPHa).

In closing, we believe consultation directly with local public health agencies, such as ours, is critical to developing the best local public health system as we move forward.

On June 5, 2019, the Halton District School Board approved the 2018-2019 Long Term Accommodation Plan (LTAP). The 2018-2019 LTAP provides enrolment projections for the years 2019 to 2028 for each Elementary and Secondary Review Area (ERA and SRA) in the Board as well as each elementary and secondary school within the system.

Enrolment projections are compared to school building and portable capacities to identify schools and review areas where enrolment pressures will occur within the immediate future. Schools that are underutilized and over utilized are identified through the LTAP, which provides data for the creation of boundary reviews dedicated to relieving enrolment pressures at certain schools or review areas. Where enrolment increases cannot be reasonably addressed through a boundary review, the LTAP also informs the Board of the need for new schools to address enrolment increases. This data forms the foundation for requests to the Ministry of Education for financial support for capital projects to build new schools or to renovate existing schools to increase capacity. Where declines in enrolment suggest the underutilization of a school, the LTAP provides data to the Board to support Program and Accommodation Reviews (PARs) that may result in school consolidations or closures. The decision to proceed with a consolidation or to request the Ministry to support a new school is made through motions of the Board.

In addition, opportunities for community partnerships will exist for unoccupied space in open and operating schools through leasing of unused space or purchase of future surplus properties of the Board. - Enrolment projections by school;
- Capacity and utilization information; and,
- Future Capital Projects (subject to Ministry of Education funding).

On October 17, 2018, the Board held its annual Community Planning and Partnerships meeting where details of suitable facility partnership opportunities and supplementary information regarding the process were presented. Following which, staff-level meetings were also held throughout the year with interested community partners to discuss potential opportunities.

The Board will host its annual Community Planning Partnership meeting to review and discuss potential partnership opportunities in the fall of 2019. A notification regarding the meeting will be circulated to all community partners identified by the Board in Appendix 1 of its Community Planning and Partnerships policy.
