## 4.2 Town Awarded for Energy Efficient Actions at Mayors' Megawatt Challenge Forum

Halton Hills received multiple accolades at the 2020 Mayors' Megawatt Challenge Forum for its leadership role in energy consumption and mitigating climate change.

The Town was inducted into the "10 Percent Club" for its positive contribution to the community's health and well-being by lowering energy use by 10% (since 2018) at the Fire Station District 1. In fact, energy use at the Fire Station was lowered by 13.7%.

Three additional leadership awards for high performance in buildings that have met or surpassed their total energy targets were awarded for Town Hall, Acton Arena & Community Centre and Cedarvale Community Centre.

These awards recognize the Town's ongoing efforts to reduce operational energy consumption and greenhouse gas emissions and align with the goals and climate change targets outlined in the corporate energy management plan.

Mayor R. Mayor Bonnette thanked the citizens who assisted the Town and helped their neighbours to clean up after the storm.

### 12.2 Protecting Conservation Authorities

Resolution No. 2020-0272

Moved by: Councillor A. Lawlor Seconded by: Councillor B. Lewis

WHEREAS the Provincial Government has introduced changes to the Conservation Act within the Bill 229, Protect, Support and Recover from COVID 19 Act – Schedule 6 – Conservation Authorities Act;

AND WHEREAS the Town of Halton Hills has been well served by Conservation Halton, Grand River Conservation Authority and Credit Valley Conservation;

AND WHEREAS the Town of Halton Hills is committed to ensure that development does not place any resident/person, business or property at risk of injury, death or damage due to flooding;

AND WHEREAS the Town of Halton Hills relies on the watershed expertise provided by local conservation authorities to protect residents, property, and local natural resources on a watershed basis by regulating development under the *Conservation Authorities Act*, ensuring compliance with the Regulations and engaging in reviews of applications submitted under the *Planning Act*;

AND WHEREAS new legislation introduces changes and new sections that could remove and/or significantly hinder conservation authorities' participation in and support of local planning appeal processes and their ability to protect development from natural hazards;

AND WHEREAS the changes allow the Minister to make decisions without consideration of local watershed conditions, the Conservation Authority Board approved policies, watershed data and technical expertise;

AND WHEREAS the Legislation suggests that the Minister will have the ability to establish standards and requirements for non-mandatory programs which are negotiated between the conservation authorities and municipalities to meet local watershed needs;

AND WHEREAS municipalities require a longer transition time to put in place agreements with conservation authorities for non-mandatory programs;

AND WHEREAS municipalities believe that the appointment of municipal representatives on conservation authority boards should be a municipal decision; and the Chair and Vice Chair of the conservation authority boards should be duly elected;

AND WHEREAS the changes to the 'Duty of Members' contradicts the fiduciary duty of a conservation authority board member to represent the best interests of the conservation authority and its responsibility to the watershed;

AND WHEREAS conservation authorities have already aligned approaches through Memorandums of Understanding with local watershed municipalities to reduce delays, avoid duplication and improve service delivery for all clients;

AND WHEREAS changes to the legislation will create more administrative costs for the conservation authorities, their municipal partners, municipal taxpayers and cause delays in the development approval process;

AND WHEREAS The Town of Halton Hills relies on a well-based system for the supply of drinking water for its residents and businesses;

AND WHEREAS municipalities value and rely on the natural habitats and water resources within conservation authority jurisdictions for the health and well-being of residents; municipalities value conservation authorities' work to prevent and manage the impacts of flooding and other natural hazards; and municipalities value conservation authorities' work to ensure safe drinking water.

THEREFORE, BE IT RESOLVED THAT the Province of Ontario work with conservation authorities to address their concerns by repealing and/or amending changes to the *Conservation Authorities Act* and the *Planning Act set* out in Bill 229 Schedule 6;

AND FURTHER THAT the Province of Ontario delay enactment of clauses affecting municipal concerns;

AND FURTHER THAT the Province of Ontario provide a longer transition period up to December 2022 for non-mandatory programs to enable coordination of conservation authority municipal budget processes;

AND FURTHER THAT the Province respect the current conservation authority/municipal relationships;

AND FURTHER THAT the Province embrace their long-standing partnership with the conservation authorities and provide them with the tools and financial resources they need to effectively implement their watershed management role;

AND FURTHER THAT a copy of this resolution be forwarded to Premier Ford, the Minister of the Environment, Conservation and Parks, the local MPPs, the local MPs, the Federal Minister of Environment and Climate Change, the Leaders of all opposition parties, Halton Region, the City of Burlington, the Town of Milton, the Town of Oakville, Conservation Halton, Grand River Conservation Authority, Credit Valley Conservation, Conservation Ontario and AMO.

#### 12.3 Opioid Crisis

Resolution No. 2020-0273

Moved by: Mayor R. Bonnette

Seconded by: Councillor C. Somerville

WHEREAS the opioid crisis is one of the largest public health emergencies of our lifetime, with a death on average about every two hours and a death toll of over 16,360 since 2016 (January 2016 to March 2020);

AND WHEREAS other countries have significantly reduced drug-related fatalities with reforms such as legal regulation of illicit drugs to ensure safe supply and decriminalization for personal use;

AND WHEREAS the federal government has indicated it is premature to discuss these measures until there are comprehensive supports for people to get well;

AND WHEREAS supports are needed, but measures that save lives are essential if people are to survive and access supports;

AND WHEREAS the Canadian Association of Chiefs of Police has stated that they agree the evidence suggests "decriminalization for simple possession as an effective way to reduce the public health and public safety harms associated with substance use", causing the government to indicate that it is now "deliberating" over decriminalization;

AND WHEREAS the overdose crisis rages, showing few signs of abating.

THERFORE BE IT RESOLVED THAT the Government of Canada declare the overdose crisis a national public health emergency so that it is taken seriously and funded appropriately;

AND FURTHER THAT the Government of Canada immediately seek input from the people most affected by this crisis and meet with provinces and territories to develop a comprehensive, pan-Canadian overdose action plan, which includes comprehensive supports and full consideration of reforms that other countries have used to significantly reduce drug-related fatalities and stigma, such as legal regulation of illicit drugs to ensure safe supply of pharmaceutical alternatives to toxic street drugs, and decriminalization for personal use;
