Re: Draft Regional Decisions

Town of Halton Hills OPAs 30, 31A & 31B

I am writing to you on behalf of Halton Region regarding Draft Decisions for the following official plan amendments (OPAs) to the Town of Halton Hills Official Plan:

- OPA No. 30 "Premier Gateway Employment Area Replacement Lands";
- OPA No. 31A "Premier Gateway Employment Area Phase 1B Lot 1 Secondary Plan"; and
- OPA No. 31B "Premier Gateway Employment Area Phase 1B Lot 2 Secondary Plan"

This letter provides background information on the Region's review of these amendments, the proposed modifications that have resulted from this review, and the next steps in the Region's decision making process.

Background

OPAs 30, 31A & 31B were adopted by Town Council on June 11, 2018 through By-law Nos. 2018-0034, 2018-0035, and 2018-0036, respectively. These amendments were not exempt from Regional approval and were forwarded along with the required supporting documents to the Region on June 25, 2018. These OPAs all pertain to the 'Phase 1B' portion of the Town's Premier Gateway Employment Area (PGEA).

In 2014, the Region and Town were required to implement corridor protection polices and mapping for the Provincial Greater Toronto Area (GTA) West Corridor Study as well as the Halton-Peel Boundary Area Transportation Study (HPBATS). Given the impact of this corridor protection on the PGEA, both the Town and Region also revised the development phasing that applied within the PGEA. In particular, the Phase 1B lands were re-phased from the 2021-2031 Regional Phase to the earlier pre-2021 Regional Phase. Despite this re-phasing, a shortfall of pre-2021 employment lands remained and a process to identify approximately 75 hectares of "replacement" lands was required.

As a result, in January 2015, the Town initiated the Phase 1B Integrated Planning Project with the purpose of a) identifying the appropriate location for the replacement employment lands and b) developing a Secondary Plan for the Phase 1B area in its entirety (that is, for the existing lands and the replacement lands). In March 2017, the Town endorsed a Preferred Land Use concept which, among other things, identified the appropriate location for these replacement lands. Informed by this decision, Halton Region adopted Regional Official Plan Amendment (ROPA) No. 47 – "An Amendment to Address a Shortfall of Employment Lands in the Town of Halton Hills' Premier Gateway Employment Area" in April 2018 to bring these lands into the Urban Area in the Regional Official Plan and enable the Town's planning for Phase 1B to move forward. ROPA 47 was appealed to the Local Planning Appeal Tribunal (LPAT) in May 2018.

In June 2018, the Town adopted three OPAs related to the Phase 1B lands. OPA 30 added lands to the Town's urban area consistent with ROPA 47. OPAs 31A and 31B set out a Secondary Plan for the Phase 1B Employment Area, with OPA 31A applying to lands in 'Lot 1' (already within the Urban Area in both the Town and Region official plans) and OPA 31B applying to lands in Lot 2 (also subject to OPA 30 and ROPA 47).

In May 2020, the LPAT issued a decision approving ROPA 47, enabling the Region to move forward with issuing decisions on these amendments, as described below.

Proposed Approval of OPA 30 and Proposed Modifications to OPAs 31A & 31B

As the Region's delegated representative it is my responsibility to ensure that local official plan amendments conform to or do not conflict with the Regional Official Plan, are consistent with the Provincial Policy Statement, and conform to or do not conflict with applicable Provincial plans. The Draft Decisions for OPAs 30, 31A and 31B are provided as Attachment #1, #2, and #3 respectively. No modifications are proposed to OPA 30. A general overview of the proposed modifications to OPA 31A and OPA 31B is provided below.

Employment Area Uses

The Secondary Plan as adopted by Town Council included a framework to recognize uses that are secondary to and supportive of the primary employment uses within the employment area. Modifications have been proposed to strengthen and clarify this relationship and to ensure secondary uses are supportive of the main employment function of the PGEA.

Natural Heritage System

In June 2018, Halton Region received the Premier Gateway Phase 1B Draft Final Scoped Subwatershed Study (SWS). Halton Region and Conservation Halton provided additional comments on this document that were addressed in an updated document dated April 2020. Both the Region and Conservation Halton have deemed the SWS to be complete to their satisfaction. Modifications have been proposed to ensure the Secondary Plan reflects the Scoped SWS as well as the natural heritage system policy framework as set out in the Regional Official Plan. Modifications have also been proposed with respect to storm water management facilities within the Natural Heritage System and Greenbelt Plan Protected Countryside area.

Transportation

On December 21, 2018, Halton Region received a draft of the Final Premier Gateway West Scoped Area Transportation Study (ATS). In March 2019, supplemental analysis was received which was subsequently incorporated into an updated version of the ATS dated May 2019 which Regional staff advised was complete to the Region's satisfaction.

On the basis of Regional staff's review of this document, a number of modifications have been recommended to ensure the transportation network identified as necessary to support the development of the Secondary Plan area is implemented effectively. In particular, the modifications highlight some of the key findings on the Area Transportation Study and areas within and outside of the Secondary Plan area that require further study. The modifications clarify that the capacity available at the intersection of Steeles Avenue and Trafalgar Road will be monitored through individual Traffic Impact Studies, and, should these studies show capacity is no longer available, the Town and/or Region may not support development until the required transportation improvements are implemented.

• Phasing & Implementation Modifications

The Secondary Plan as adopted by Town Council contained general references to phasing and implementation that were to be updated pending the completion of the Town's Area Transportation Plan and the Region's Area Servicing Plan. General direction with respect to phasing has been provided in the Region's Draft Decision.

• Clarity / Readability Modifications

As a result of the detailed review of the amendments undertaken by Region and Town staff, a limited number of modifications are proposed to increase overall clarity and readability.

Mapping Modifications

Certain changes are proposed to Schedule H5A, H5B, and Appendix B. These changes are largely to provide clarity with respect to the transportation network.

Conclusion & Next Steps

With the proposed modifications as described above and shown in Attachments #2 and #3, Regional staff are of the opinion that OPAs 30, 31A and 31B conform to or do not conflict with the Regional Official Plan, are consistent with the Provincial Policy Statement, and conform to or do not conflict with other applicable Provincial plans and policies.

Regional By-law No. 6-16 delegates the approval authority under Section 17(34) of the *Planning Act* to the Chief Planning Official, provided that the Chief Planning Official's decision is not contrary to the recommendation of the local municipal council. I understand that you will be taking a report to Town Council regarding these proposed modifications. I will await Town Council's response to this letter before issuing the Notices of Decision. Should Town Council not support the proposed modifications, the matter must be referred to Regional Council for a final decision.




