RE: Award of the Proposal P-047-21- Engineering Services for Main

Street (Glen Williams) Improvements

RECOMMENDATION:

THAT Report No. TPW-2021-0018, dated June 14, 2021 regarding the Award of the Proposal P-047-21- Engineering Services for Main Street (Glen Williams) Improvements, be received;

AND FURTHER THAT Council approves the Engineering Services for Main Street (Glen Williams) Improvements contract award to AECOM Canada Ltd., 105 Commerce Valley Drive West, 7th Floor, Markham, Ontario L3T 7W3;

AND FURTHER THAT the Senior Manager of Purchasing and Risk Management be authorized to issue a Purchase Order to AECOM Canada Ltd., 105 Commerce Valley Drive West, 7th Floor, Markham, Ontario L3T 7W3, in the amount of \$603,837.00 (excluding HST), for the purpose of Design Phase Engineering Services for Main Street (Glen Williams) Improvements, with Construction Phase Engineering Services to be submitted for Council approval at time of Construction Tender Award;

AND FURTHER THAT Council authorizes the Mayor and Clerk to execute the necessary documents to enter into a Client/Engineer Agreement for Professional Consulting Services.

BACKGROUND:

In 2020, Capital Budget, monies were allocated and approved for the design of the Main Street (Glen Williams) Improvements in the amount of \$650,000.00.

The project includes a stormwater management study for the Main Street (Glen Williams) study area, condition assessment and rehabilitation recommendations for Bridge 1 and Bridge 2 along Main Street over the Credit River, full engineering design

and investigative services for reconstruction of Main Street and adjoining streets within the study area, and preliminary design of Confederation Street improvements between Main Street and Bishop Court.

Two (2) Construction Tenders are anticipated as output from this project: Rehabilitation of Glen Williams Bridge 1 & Bridge 2 Tender; and, Main Street Reconstruction Tender. Construction Phase Engineering Services for Rehabilitation of Bridge 1 & Bridge 2 and Main Street Reconstruction have been included on a Provisional basis and will be subject to Council approval at time of Construction Tender Award.

COMMENTS:

A Request for Proposal (RFP) for the Engineering Services for Main Street (Glen Williams) Improvements was issued on March 10, 2021. The bid was posted on the Town's website and advertised on the bidsandtenders.ca website. Thirteen (13) firms downloaded the document. The RFP closed on April 20, 2021 and seven (7) submissions were received as follows:

Bids were evaluated by a staff team based on experience, price, methodology, project approach and understanding, and work schedule. AECOM Canada Ltd. was determined to be the highest ranking proponent.

Detailed engineering design will be undertaken in 2021-2022. Construction activities for Rehabilitation of Glen Williams Bridge 1 & Bridge 2 are anticipated in 2023. Construction activities for Main Street Reconstruction are anticipated in 2024.

RELATIONSHIP TO STRATEGIC PLAN:
